- e. Ms. Alonso will enter GCBA's honey in all 3 honey classes in the Fair. Mr. Manthey will drop off the submissions.
- f. Tickets for the volunteers and members for the meeting will be given to Mr. Alonso. He will reach out to Mr. Eck if the Club needs more.
