

a. Ms. Alonso reported that she made the appropriate changes to the minutes

- b. Ms. Alonso stated Mrs. St. Clair had reached out to Robert Najjar, the President of the Summit County Beekeepers Association to speak at our May meeting. Mrs. St. Clair relied that Mr. Najjar will be speaking about what it means to be a beekeeper. Ms. Alonso will reach out to Mr. Najjar to be sure be has what he needs for the meeting.
- c. Mrs. St. Clair stated that OSBA has speakers that are willing to come out to speak to the membership if we would like to utilize that resource. For June, we could have a speaker talk about queen management, supering, summer build up, or races of bees. Mr. St. Clair will reach out to Dave Noble to speak about queen management.
  - July is the annual summer picnic so there is no need to schedule a speaker. We will need to get the date to Dennis Eck so he is aware of GCBA using the pavilion. August is the fair and will have our regular meeting during the fair, just as we did last year.
- d. Ms. Alonso reminded the group that the board still needed to pay Ms. Garnes for speaking at the April meeting. When Mr. Alonso asked Ms. Garnes about her typical payment she stated that it is usually repayment for her mileage. Mr. St. Clair pointed out that in order to obtain high-quality speakers we need to pay them for their time.

New Business S. Alonso

a. Mr. Kennish has stepped down as the GCBA President. Mr. St. Clair stated that Mr. Alonso should take on the President position for the remainder of the term. Mr. Alonso is in possession of the AV equipment, computer and tri-folds. Mr. Petrek suggested that we create an inventory of equipment. Mr. Alonso also suggested that we have all GCBA equipment locked in the extraction room so that it is all in one place.

- b. Ms. Alonso reminded the group that we are still looking for a fair chair. Mr. St. Clair suggested that it is announced to the membership and ask for a volunteer. Ms. Herzberger asked if there was a description of the fair chair's responsibilities. Mr. St. Clair stated that there was not, but one should definitely be created, This is only the 3<sup>rd</sup> year that GCBA has participated in this function at the fair. Ms. Herzberger will work with Mrs. St. Clair on a role description and will place the request in the newsletter.
- c. The topic of fundraising was brought to the table. Mr. Alonso suggested a Night at the Races. Mr. St, Clair stated that GCBA would need the Fairground Board approval to hold an event and suggested asking the membership if that would be of interest to them.
- d. Mr. Alonso stated that he was confused on who is responsible for the bee yard and asked if the bees in the yard are the fairgrounds or GCBA or is it a joint venture. Mr. St. Clair stated that the bee yard is GCBA and the equipment and bees belong to the fairgrounds. We will take care of the bees and use the yard for education and spreading the GCBA mission. We can have Saturday meetings for demos for new beekeepers and possibly work with LCBA to spread the word about the bee yard.

World Bee Day Shelia St. Clair

a. Mrs. St. Clair stated that WBD committee did a walk through of the grounds. Mr. Bartosh volunteered to do a hotdog stand to raise money for GCBA. He will purchase the food and will donate the funds for the permit.

Old Business M. Alonso

- a. Ms. Alonso stated that since Mr. Kennish stepped down we need a board member to take on the square/card reader. Mr. Alonso stated that he would do this, but stated that there still needs to be a two-person authentication. He will work on creating an email for the account and will purchase the square. Mr. Bartosh reiterated that the reader needs to be linked to the website so that we can take payment and donations from the site. Mr. Alonso will work with Ms. Theurer to get this taken care of.
- b. Mr. Manthey reported out that the wall hive and one hive out in the yard have had bees installed. The queen in the bee yard is out, but not too sure about the wall hive. We are waiting for Rick Moranz to catch swarms to put in the other two hives.
- C. Mrs. St. Clair reminded everyone that the garden sign still needs to be hung. We still need to obtain a quote for the installation of fencing around the bee yard. Mr. and Mrs. St. Clair will work on this. Petites has donated \$100 for the purchase of ornamental trees. Mr. Bartosh will speak with John Rini about plants. We will need to purchase and spread mulch.
