Treasurer's report:

Savings balance \$13,007.48, ending balance \$13,007.70. Checking balance \$6,878.01, ending balance\$6,879.01 (outstanding \$100 check will bring checking balance to \$6,779.01 once cashed). Motion to accept Treasurer's Report by D. St. Clair, second by T. Mckenna. Approved by all.

Motion to pay \$100 to Cuyahoga County Fairgrounds \$100 for January building use by D. St. Clair, second by P. Bartosh. Approved by all.

Discussion about paying Fairground more than \$100 for February as GCBA will use building 4-5 evenings due to Beginner Beekeeping Classes plus Executive Meeting. L. Theurer reminds board the payment is a donation, not payment of an invoice. P. Bartosh recommends \$100. D. St. Clair moves to pay \$100 to fairgrounds in February, second by T. McKenna. Approved by all.

Treasurer did not move \$5000 from checking to savings because DNO (and possible Farm Bureau) insurance bills are coming due.
