

Meeting officially called to order at 6:30pm

Public Comment

The members of the Cuyahoga County Fair Board have requested a donation from the Greater Cleveland Beekeepers Association to support the annual "Tractor Pull" at the 2024 Cuyahoga County Fair. Typically, this event is sponsored by the Farm Bureau, but this year, the Bureau has significantly reduced their donation. The President of the Fair Board has mentioned that if the GCBA makes a donation, the association will be recognized as a sponsor on all marketing materials.

Treasurer Report Brenda Theurer

Ms. Theurer informed the board that she has updated the State of Ohio certification. She replaced Kathy Smith with her name as the appointed agent. Mr. Price stated that we need to have this updated more regularly to reflect the current board members.

Ms. Theurer also reviewed the following items with the board:

- c. She reminded Ms. Alonso to send the September, October, December, and June minutes to Katherine to be posted on the website.
- d. The mailing address for membership registrations needs to be posted on the website.
- e. Ms. Theurer stated she reviewed the by-laws due to the canceled meeting in April. She asserted the by-laws stated meetings are to be held each month. However, with further review it was found that a meeting can take place by email. It was decided that if an in-person meeting needed to be canceled due to weather conditions or other unforeseen circumstances, the board would meet via Zoom.

Bee Yard Beautification S. St. Clair

- a. GCBA has received several donations including from Petite's. Mr. Petrek volunteered to pick up the plants and two trees. He will also pick up mulch if the garden center has any available. We have also received 200-300 seed packets to pass out at World Bee Day.
- b. Mr. Petrek has mowed and weed-wacked the yard and Ms. Brown planted the donated yarrow root.Mr. Manthey has been working in the hives and they look ready for World Bee Day.
- c. The following was also reviewed for WBD:
 - a. Fairgrounds rented tables and chairs for GCBA to use for the event
 - b. Apples have been delivered
 - c. There will be a fence erected to block off the buildings from the school busses

- d. May 22, will be the Bee Yard Clean-Up day. An email will go out to members to volunteer their time.
- e. Grants should be looked at to help maintain the yard and needed equipment.

New Business S. Alonso

- a. Ms. Alonso suggested Kim Young as June's speaker. She has volunteered to speak about native plants and planting pollinator gardens. Mr. St. Clair stated that we should be creating a Queen Rearing program and suggested a speaker that will teach the Damaree method. He volunteered to find the speaker. He asked Mr. Manthey to learn the method and to offer a class. Mr. Manthey stated that he would and will also schedule time to have a hands-on presentation on queen grafting.
- b. For the Annual Picnic the club will supply hamburgers, hotdogs, and drinks. The picnic will be in the pavilion from 6-8 pm. We will have corn hole and a smoker contest. Queen Right Colonies will donate a basket of smoke fuel. We will also raffle off a split of a queen (depending on the current situation in the hives) Tickets for the split will be \$5 and queen \$1.
