# Meting officially called to order at 6:42pm

Treasurer Report B. Theurer

b. Ms. Theurer filed the GCBA 990 and updated the charitable donation statues with the state.

Secretary Report S. Alonso

- c. Ms. Alonso reported out that there 58 members in attendance at our last membership meeting
- d. Ms. Herzberger asked the group about how we go about billing for the ads in the newsletter. Mr. St. Clair stated to check the by-laws. It was decided that the secretary is to bill for the ads.
- e. Mrs. St. Clair stated that Dave Noble from Red Beard Bees will be speaking at the June meeting. The topic will be Queen Management in Urban Beekeeping. There will be a fee, but she is unsure of the amount. Ms. Theurer stated that once she receives the amount she will send over a check.

f. Mr. Bartosh reminded the group that we will need to purchase food for the July picnic. He stated that if there is left over food from the World Bee Day event, we will not need to purchase much more. Mr. St. Clair put a motion on the table to allow \$300 to be spent on the purchase of additional food for the picnic. Mr. Bastosh has been in contact with the member and the member is recovering. Mr. Bartosh bought signs for the bee yard indicating a veil is required to enter.
- i. There will be no speaker for the July picnic. We will have the regular bee meeting in August during the week of fair in the bee barn, just as we did last year. Charles volunteered to speak during fair week and the topic will be cooking with honey.
- j. Mr. Bartosh volunteered to speak at a vacation bible school that reached out for a speaker.

New Business M. Alonso

- a. Mr. Alonso stated that we are still looking for Fair Chair. The board should go up to members during the next meeting and directly ask if people would like to volunteer. Mrs. St. Clair said that she will help whoever volunteers for the role.
- b. We will also need to make an announcement that we will need honey frames for the fair to be used in the extraction room. In exchange for the extract the member can either work the booth or pay.
