At the annual Board of Directors meeting each board member will sign a disclosure of conflict of interest of any known or anticipated conflict. All conflicts of board member relationships or transactions shall be brought to the Board of Directors at the next board meeting.

A conflicted relationship or transaction of a key staff member (not the Exe-Director) is fully disclosed to the Board of Directors upon the knowledge of the conflict to the Exe-Director.

Final resolution of the conflict of interest resides with the Board of Directors. The conflicted director or stall member may be present at the discretion of the board but would have no vote and would not be counted to establish a quorum.
