## Deposits

All deposits paid for a course, are NON REFUNDABLE. Deposits can be moved across to use for another course, or another treatment, but moneys will not be returned. The same rule applies, should you pay on a non credit monthly plan. For example, payments made, can again, be switched across to a treatment or a differing course, but fees themselves will not be returned.

## Vocal and Signed agreements

Upon booking your course, it is ALWAYS discussed in detail, what the course entails, pre requisites, theory and practical basis, how many days, if any added fees are active, should you require extra training. On day one it is essential that we run through the signed acceptance contract with every student, this is a simple contract to prove that you have understood the context of the course, the course cost, the accreditation held for the course you are taking etc.

## Discretion of the Trainer

As a qualified lecturer, with the relevant background of said subject, it is up to the trainer to decide whether or not you have passed to a sufficient standard. At Rejuv Cosmetology, we will give a certain amount of extra learning time, complimentary, but over 6 hours additional time, we have the right to charge a fee of £100, additional learning payment.

## Student Learner Type

On day one, we work with you to establish your type of learning style, we cater to all individuals understanding and levels. This will be reflected on your learner profile information sheet, so that we can give the fairest form of assessment. Learning difficulties are also catered too.

## Course Aftercare

Upon completion of the course, you will sign a final feedback contract, to confirm you have understood the subject, both theory and practical based. We take pride in offering you on-going life time after care. You will be awarded your certificates, usually on the day, unless otherwise discussed, and upon awarding of the qualification, in exchange from Rejuv Cosmetology to you (the student), you are accepting that you feel capable at this time of acceptance. Your personal experience there after, cannot be determined by Rejuv Cosmetology, we take ONLY responsibility for your skill and understanding whilst on our premises, within the allocated training hours.
