

## Zero Pollution Network Limited Membership Terms and Condition

## **Definitions:**

In the following Terms and Conditions for elimination of doubt, the use of the word Network in singular or plural are understood to refer where applicable to the Zero Pollution Network Limited. The term Member is used collectively to refer to Network Members, Associates, Media Partners, Followers, Consultants, Individuals working with or via the Network.

## **Terms and Conditions:**

- a) While particularly focused on helping small to medium sized firms achieve scale and breadth in their solutions Membership of the Network is open to any business, manufacturer, company, component supplier, society, academic institution, trade body, fundraiser, consultancy, innovator or individual that believes they can contribute to delivering the Network's aim of achieving Zero Pollution either working in isolation or with other Network Members.
- b) Membership of the Network gives Members access to Network facilities, information, networking prospects, events such as Zero Pollution Network exhibition pavilions, documentation, branding materials such as logos, special Members offers, incentives, promotional programs and subject to status, access to funding, exit strategies, products/technology transfers to empower Members to achieve and deliver solutions to combat aquatic pollution and/or climate change.
- c) The Network reserve the right to refuse Membership to applicants without an obligation to state the reason and without liability.
- d) Members may network freely with fellow Network members at any time. Should they wish to approach fellow Members without disclosing their identity, they must post their requests via the Networks administrators who will forward on the request agnostically to select Members. In doing so Members accept that the Network cannot accept responsibility for breaches in identity that may arise.
- e) Members are not permitted to share, transfer or re-sell Network benefits to non-Members outside the Network.
- F) The information presented on or through the Network website or events is made available solely for general information purposes. We do not warrant the accuracy, completeness or usefulness of this information. Any reliance you place on such information is strictly at your own risk. We disclaim all liability and responsibility arising from any reliance placed on such materials by you or any other visitor to the Network website, or by anyone who may be informed of any of its contents. further, the Network materials, third party content, and any benefits or other materials that we may offer through the Network are provided "as-is." except to the extent prohibited by law, we make no representations or warranties of any kind, whether express, implied, statutory, or otherwise, with respect to the Network materials, third-party content, and any benefits or other materials that we may offer through the Network including any implied warranties of performance, merchantability, satisfactory quality, suitability for a particular purpose, non-infringement, or quiet enjoyment, any warranties that the materials or third-party content will be error free or free of harmful components, defective materials and any warranties arising out of any course of dealing or usage of trade of goods or services.

- h) The Network does not control or assume any liability for Third-Party Content. If there is a conflict between this Agreement and the Third-Party Content provider's terms, this Agreement will control.
- i) The Network cannot be held responsible for any commercial, proprietary and trade secrets, IP or patent infringements or IP theft, either alleged or proven associated with its Members or between them and third parties.
- j) Members are required to hold their own public liability insurance of at least £5m GBP if attending taking part in a Network event or taking up a booth on a Network pavilion at a trade show.
- k) The enforcement of confidentiality agreements between fellow Member or Members and third parties will be the sole responsibility of the Members respectively.
- In joining the Network, Members understand that opinions, statements or listings, appearing on the Network's website are presented in good faith, without warranty or guarantee, and are assumed to be an honest reflection of the Member status, products or services where it is assumed that the Member has accepted to responsibility to inform the Network's administrators in writing concerning the presence of any errors or omissions.
- m) All applicants and Members of the Network consent to Network or fellow Members conducting from time to time a credit search.
- n) All Members are responsible for holding adequate and appropriate insurance to cover the scope of their activities. In joining the Network, the Members understand that the Network stands at a distance from all transactions and cannot held responsive or accept any liability whatsoever for any Members liabilities.
- o) Details of Members, as provided by the member in question, are held by the Network on its CRM system and website, in accordance with best practice and if applicable GDPR. Members' information will be published via the Internet, on the Networks website, in a members' solutions directory, as part of the Networks commitment to the promotion of best practice for the greater good.
- p) The Network is entitled to terminate a Members membership at any time and for any reason without compensation. This may include and not exclusively, a material breach in this Terms and Conditions of Membership, prolonged inactivity, breach of Network's code of ethics and any Member which brings the Network into disrepute.
- q) Members may state the fact that they are Member of the Network and use the Network's logo in their publicity and correspondence. If asked to leave the Network, past Members must take all reasonable actions to remove reference to Network Membership from their website and any correspondence within 48-hours.
