**03/24 Public Representations**: The clerk advised the council had received an enquiry from a parishioner on the future of the Fernhurst Club. The parishioner was referred to the Trustees of the charity responsible; the council being unable to provide further information.

**07/24 District Council Commentary:** Chichester District Councillors Brett Burkhart and Elanora Newbery had provided a written report on CDC activity at the District level on a range of issues.

The Food Waste Recycling obligation has been imposed on local councils by central government with a March 2026 deadline.

More local initiatives include Laser Light Shows at Chichester Basin, Novium Museum ambitions with the Shippams archive, and pond dredging and improved access pathways in Midhurst.

The councillors had recently met with the Sussex Police & Crime Commissioner to press local concerns with unauthorised encampments, road safety issues and rural crime.
