

# Parish Council Meeting Minutes Wednesday 12 October 2022

Minutes of the Meeting of Fernhurst Parish Council held at Fernhurst Village Hall on Wednesday 12 October 2022 at 7.00pm

128/22 Apologies for Absence: Mr N Barker, Mr M Giffin, Mrs M Jenkins, Mr C Lloyd.

**129/22 Declarations of Interests:** Cllr Bicknell declared an interest in the grant application from the Fernhurst Recreational Ground Trust as an ex-officio trustee of the trust.

130/22 Public Representations: None.

**131/22 Previous Minutes:** The Minutes of the meeting of the **20 July 2022** were approved.

132/22 Matters Arising From The Minutes Not Covered Below: None.

**133/22 County Council Commentary:** West Sussex County Councillor Tom Richardson updated the meeting on the progress of the countywide Road Safety Review covering traffic management and speed limits. It is likely that a 40mph blanket limit will be imposed on what are effectively country lanes (currently 60mph) and 20mph zones will become more widespread in towns and villages. Cllr Richardson advised that road drainage issues were being made more of a priority.

**134/22 District Council Commentary:** The Chichester District Council report from District Councillor Peter Wilding was received. The "Chichester – Supporting You" campaign has been funded for two years. The council has applied for £13 million of Levelling-Up Funding from central government mainly covering projects in and around Chichester. Connected Kerb have been chosen as the council's preferred contractor to provide commercial kerbside Electric Vehicle charging facilities in the district.
