45/24 Christmas Arrangements: A licence remains to be obtained from Chichester District Council for the Christmas Lights event on Tuesday 3 December. The licence should also include permission to install a defibrillator at the Crossfield precinct. **Action: (Clerk)**

47/24 Bank Deposit Accounts: The council's National Savings & Investments Account (which had originally been opened on 26 January 1989) was closed on 13 March and the balance transferred to the NatWest 35 day Notice Account in search of better returns.

48/24 Bus Shelter – Kingsley Green: The on-line application form to establish if planning permission is required, the Village Ranger having provided technical input. **Action: (Clerk)**

49/24 Playground Refurbishment: The contractor has finished the new safety surface installation which was carried out in far from ideal weather conditions. An initial appraisal of the installation considers it to be satisfactory.

Installation of new spring rockers, swing seats and chains to follow. Action: (Clerk)

50/24 Fernhurst Park Development: Cllr Bicknell advised the meeting of the advice she had received on the quantity of Community Infrastructure Levy (CIL) funding that would be available to the council on the progression of development at the Fernhurst Park (Syngenta) housing site.

The developer has permission to split the project into multiple phases. Phase 1 is apparently progressing at the plan and design stage but no CIL funding is payable on this initial phase.
