It has not been possible to construct the whole project in one phase due to shortfalls of available finance needed to meet the large increase in construction costs. The plan was to build 75% of the scheme in one phase and then complete the balance of the build as soon as sufficient funds are available. The space that has been designated as a second phase is the north west of the scheme (when viewing the drawings) which featured the entrance, office and storage areas. However, an alternate principle has now been established that would be affordable within the single first phase, and in many ways provides a neater overall solution. This involves forming an entrance corridor space that provides a point of access from the car park and links into the existing construction in that corner of the site which can be modified to provide toilets for the building set off this entrance corridor. The building in other respects remains the same or reduces in scale so no increase in the footprint, the height or the massing of the building will take place and, if anything, the impact on the residents to the north of the recreation ground will be impacted less.
