The poor quality of the design does not do justice to the host building or the wider setting. The council also objects to the three proposed roof-lights which do not comply with Local or Neighbourhood Plan Dark Skies policies. Mitigations such as blinds are effectively unenforceable.

Both objections could be easily overcome with a better design, a pitched roof and more vertically orientated glazing.

The council does object to the proposed roof-lantern which is not compliant with Local or Neighbourhood Plan Dark Skies policies – mitigations such as blinds are effectively unenforceable. A roof-lantern with vertical glazing only would not be objected to.
