PHE/41/22 PREVIOUS MINUTES

PHE/43/22 HIGHWAYS / WINTER RESILIANCE / BUS SHELTERS

Traffic Consultant & CCTV: Cllr Buchanan advised the meeting that a Cranleigh based company was advising on the possibility of CCTV at the Fernhurst crossroads and that he awaited a call-back from the traffic consultant he was in communication with.

Speed Indication Devices: West Sussex County Council have produced a policy document on the siting of Speed Indication Devices (also known as Vehicle Activated Road Signs – VAR's). Any additional VAR's will have to comply. The VAR outside of the Fernhurst Club is not functioning and repair is being pursued through WSCC Highways Dept. **(Action: Cllr Barker/Clerk)**

Damaged Road Signs: WSCC Highways have advised that all of the road sign issues are in their books "closed". It would appear there is a policy not to replace damaged road signs unless considered vital.

Grit Bins/Winter Resiliance: The agreement with the contractor has been approved for another year.

Fernden Lane Bus Shelter: Currently in abeyance to facilitate the completion of other projects.

Kingsley Green Bus Shelter: Fordham Brothers were engaged on 4 October to carry out the repairs.

PHE/44/22 - VAN COMMON / VILLAGE GREEN

Van Common: John Jordan is to clear drainage ditches.

Tree Inspection: Clerk is to instruct the contracted tree inspector to proceed. Action: Clerk

PHE/45/22 - PUBLIC TOILETS: The railings on the access path to the disabled facility have been damaged by a vehicle apparently reversing into them. A local fencing specialist has been to site and a quotation is awaited. **Action: (Clerk)**

PHE/46/22 PLAYGROUND
