PHE/95/21 PREVIOUS MINUTES

PHE/97/21 TREE MANAGEMENT

The two year cycle of a professional inspection of council owned trees was considered appropriate and in line with insurance requirements. Councillors would undertake an inspection in between and as deemed necessary.

PHE/98/21 WINTER RESILIANCE

Two new grit bins at Marley Hanger and Paddock Close are to be added. Existing grit bin levels are to be checked. The possibility of adding the grit bin in the Surgery car park is to be examined. **Action: (Clerk)**

Cllr Lloyd reported that Easebourne Parish Council are not responding to approaches seeking support for a speed limit reduction on a section of the A286.

There appears to be no support in the parish for the creation of a Community Speed Watch Group that the council would be willing to support.

- 5) Installation of Wallgate unit in Mens facility.
