Decision: No objection in principle. The council does object to the proposed additional roof-lights which do not comply with Local or Neighbourhood Dark Skies policies. This is a particularly unpolluted, sensitive area, and these could and should, be designed out of the scheme. Mitigations such as blinds are effectively unenforceable.

Proposal: New all-weather access track linking with existing track running through

Fern Wood.

Location: Land at Fernden, Kingsley Green, Haslemere, GU27 3LQ,

Decision:

The council has strong concerns on two grounds: road safety, and the potential for visual degradation of a sensitive site. This site is in open country which forms part of

a 'gateway' to the SDNP and a 'strategic gap' between the suburban areas of Haslemere and Fernhurst.

The council also has concerns over the possible additional future uses to which a permanent access track may be put, and a potential lack of control over these. In forestry terms, this is a relatively small area of land and there would appear to be no real justification for a permanent accessway. The council would strongly prefer to see approval given for a temporary accessway only, with the timing and extent of its usage to be tightly controlled by conditions attached to any consent. Such temporary access arrangements are not unusual when extracting timber from relatively small areas in sensitive locations.
