Proposal: Splitting existing garden into two and erection 1 no. dwelling with shared

existing vehicular access.

Location: Land to rear of 1 Hawksfold House, Hawksfold Lane East, Fernhurst,

GU27 3JW

Decision: The council objects. The application represents overdevelopment of the site, and proposes inadequate vehicular parking. Hawksfold House is a listed building and the building of another house, of non-vernacular design, so adjacent, does not complement the curtilage of a listed building.

The council deprecates the alleged destruction of apparently semi-natural ancient woodland prior to any ecological survey and would seek assurance that any tree felling did not violate TPO 70/00459.
