

## **WAXING SERVICE LIABILITY WAIVER & CONSENT FORM**

### **PLEASE READ CAREFULLY BEFORE BOOKING YOUR SERVICE**

This Waxing Service Liability Waiver and Consent Form (the "Agreement") is made between the undersigned client (the "Client") and Diamond Jackson (the "Service Provider"). By booking and paying for any waxing service, the Client acknowledges and agrees to the following terms:

### **1. CONSENT TO TREATMENT**

I, the Client, voluntarily consent to receive waxing services from Diamond Jackson. I understand that waxing involves the removal of hair from the root using wax and may result in skin irritation, redness, swelling, bumps, bruising, allergic reactions, ingrown hairs, and/or minor bleeding.

### **2. CONTRAINDICATIONS & DISCLOSURE**

I confirm that I have disclosed any of the following conditions that may affect my waxing service:

- Use of Retin-A, Accutane, Differin, or other topical/oral skin-thinning medications.
- Recent chemical peels, laser treatments, or microdermabrasion.
- Diabetes, varicose veins, or circulatory disorders.
- Sunburn, open wounds, rashes, skin infections, or severe skin sensitivity.
- Pregnancy or hormonal changes that may affect skin sensitivity.

I acknowledge that failure to disclose any condition may increase my risk of adverse reactions, and I release the Service Provider from any liability should such reactions occur.

### **3. POTENTIAL RISKS & AFTERCARE**

I understand that:

- Waxing may cause temporary discomfort and irritation.
- I am responsible for following all aftercare instructions provided by Diamond Jackson.
- Results vary based on individual skin type, hair type, and adherence to proper pre- and post-wax care.

### **4. LIMITATION OF LIABILITY**

I hereby release, discharge, and hold harmless Diamond Jackson and its employees, contractors, and representatives from any claims, damages, or injuries arising from waxing services. I acknowledge that the Service Provider is not a medical professional and does not diagnose, treat, or prescribe medical conditions.
