 - **8th Demerit or more:** May result in ISS or OSS (Dean contacts the parent)
- Demerits will be reset at the beginning of **semester 2**.

To this on 1/10/25:

Please be sure you thoroughly read the requirements below for the reward trips at the end of the year:

- At the end of the year, students can attend a field trip as a reward for their behavior.
- Students who earn ISS or OSS during **2nd semester**, to include for tardies and demerits, will NOT BE ELIGIBLE to participate in the grade-level reward trip.
 - 6th demerit = ISS
 - 8th tardy = ISS
