BULLYING AND HARASSMENT REPORT

Pursuant to School Board Rule 3.21, in mid-May 2025, Petitioners James Stoner, Linda Carnall and Alexandra Pillay filed bullying and harassment complaints against Matthew Ross. The Petitioners are St. Johns County School District employees who are on staff at Switzerland Point Middle School (SPMS). Ms. Carnall is the principal, Ms. Pillay is an assistant principal, and Petitioner Mr. Stoner is a math teacher. Mr. Ross is the parent of a student at the school.

BACKGROUND

In late November 2024, Petitioner Stoner was told by a student that Mr. Ross' son had written "[Classmate's Name] is a n*****" on his classroom white board while Petitioner Stoner was out of the room. Petitioner Stoner called Mr. Ross and the parents of the African American classmate whose name was written on the board and told them what had transpired.

Mr. Ross did not believe that his son would do such a thing and that afternoon, came to school and met with Assistant Principal Pillay. The school duly conducted an investigation of the incident. While other students in the class confirmed what had been written on the board, none of them professed to know who did it. The school determined that the evidence was insufficient to substantiate the accusation against Mr. Ross' son and did not impose any disciplinary consequences. Mr. Ross requested the school transfer his son out of Petitioner Stoner's class, which the school did.

Mr. Ross filed a bullying and harassment complaint against Petitioner Stoner over his handling of the incident. The school investigated the complaint and determined that it was unsubstantiated.

Mr. Ross was unhappy with the outcome and in late April launched a campaign to have the Petitioners fired and arrested for child abuse.

SCHOOL BOARD RULE 3.21

St. Johns County School Board Rule 3.21 tracks Florida Statute 1006.147. They categorically prohibit bullying and harassment in the school environment. As the introduction to the rule states:

The St. Johns County School District believes that all of its students and employees be afforded an educational setting that is safe, secure, and free from bullying and harassment of any kind.

The St. Johns County School District will inspire good character and a passion for lifelong learning in all students, creating educated and caring contributors to the world.

Paragraph 2a. defines “bullying” broadly, as follows:

Bullying means systematically and chronically inflicting physical hurt or psychological distress on one or more students or employees. Bullying includes cyberbullying ... and also may involve:

* * *

- iii. Threat
- iv. Intimidation
- v. Stalking

* * *

- viii. Sexual ... harassment
- ix. Public or private humiliation

“Bullying” is further defined as unwanted and repeated written, verbal, or physical behavior, including any threatening, insulting, or dehumanizing gesture, by an adult or student, that is severe or pervasive enough to create an intimidating, hostile, or offensive educational environment [or] cause discomfort or humiliation.

Paragraph 2d. defines “harassment:”

“Harassment” means any threatening, insulting, or dehumanizing gesture, use of data or computer software, or written, verbal or physical conduct directed against a student or school employee that places a student or school employee in reasonable fear of harm to his or her person ... or substantially disrupts the orderly operation of a school.

Paragraph 2e. elaborates on the definitions:

“Bullying” and “harassment” also encompass:

- (i) Cyberbullying and cyberstalking as defined above.

- (iii) Perpetuation of conduct listed in the definitions of bullying and harassment by an individual ... with intent to demean, dehumanize, embarrass, or cause emotional or physical harm to a student or District employee by:

- Acting in a manner that has an effect substantially similar to the effect of bullying and/or harassment.

FINDINGS

Mr. Ross has been systematically and chronically bullying Petitioners since April 29, 2025. Since then, he has hounded them relentlessly, both in person and through emails, an online website and social media.

1. The Website

On or before April 29, Mr. Ross set up a website named "FireJamesStoner.com." The opening page declares "ITS TIME TO GET RID OF RACIST, BULLY TEACHERS AND ADMINISTRATION." It displays headshots of Petitioners, with Petitioner Stoner's captioned:

James Stoner
Racist, Bully, Liar and All Round Idiot.

(Ex. B at 1).

The "Supporting Documents" section contains emails and photographs, accompanied by vulgar name-calling and commentary. Page 3 of 6 states:

Ah yes, good ole Al Pillay, What a total and complete idiot lying piece o' s**t this "lady" is. She needs to be fired and arrested along with the rest of them.

Page 5 of 6 is directed at Principal Carnall:

I keep this email open, always, its what made me ultimately put this together and buy a banner. Hey Linda Carnall F**K YOU YOU CHILD ABUSING GROSS DISGUSTING Center of the ballon no stank a**hole cling on piece of s**t, I hope you ROT and feel "sorry" for what you did to all these kids you f**king lowlife. you are a bad bad person that makes this world s**ttier. you f**king suck as a person who interacts with our children and as a human taking up air on this planet.

Page 6 of 6 features a photograph of an unidentified man giving the finger with the caption:

Not sorry at all Linda Carnall you s**tstain.

James Stoner, Alexander Pillay, and Linda Carnall, F**K YOU you f**king IDIOTS.

(Ex. B at 1).

The website provides links to Change.org to sign petitions calling for Petitioners to be fired, entitled:

Stop Racist Child Abusing Educators and the Evil Demon who
Helps Them, James Stoner

2. The Videotaped Sidewalk Demonstrations

Mr. Ross' bullying of Petitioners has been chronic and systematic. Beginning April 29, Mr. Ross would show up almost every day at SPMS when school was letting out and buses and parents were picking up children. He would set up on the sidewalk along Greenbrier Road across from the school and spend up to 45 minutes walking the sidewalk.

On his sidewalk visits, Mr. Ross carried a large sign, which he displayed to passing motorists and pedestrians in the vicinity. It stated:

Firejamesstoner.com
Help me rid our school of this racist abuser of our children
FB @ sjcsd_truth

On occasion, he also would appear later in the day with his sign on the sidewalk across the street from nearby high schools.

While pacing up and down the sidewalk, Mr. Ross would videotape himself aggressively and profanely disparaging Petitioners as "child abusers," "criminals," "racists," "c**ts," "pieces of s**t," "b***hes," "a**holes," "douchebeteers," "scumbags" and the like. He repeatedly called for Petitioners to be fired and arrested. His twin mantras were "fire James Stoner" and "start with Stoner." He accused Petitioner Stoner of making up the n-word incident, claiming "It didn't happen. It was a total fabrication because James Stoner didn't like my son." (T. at 67)

Mr. Ross' accusation against Petitioner Stoner was palpably false. During the school's investigation of the incident, several students confirmed that the n-word had been written on the board, but they did not know who did it. There was some evidence implicating Mr. Ross' son, but the school determined it was insufficient to substantiate that he was the perpetrator.

Mr. Ross' live audience consisted of parents picking up their children, motorists and pedestrians passing by, and teachers and staff on school grounds across the street. Sometimes he would talk to himself directly into the video camera. He also used a bullhorn to personally call out Petitioners across the street at the school with insults, taunts and threats. He also made it a point to station himself on the sidewalk where he could be seen from Petitioner Stoner's classroom.

3. The Facebook and TikTok Postings

In order to leverage his audience and increase what he called the “pressure, pressure, pressure” (Ex. A at 6) he was seeking to put on the Petitioners, Mr. Ross would post the videotapes of his performances on his TikTok account and two Facebook accounts ([Tiktok.com/@firejamesstoner.com](https://www.tiktok.com/@firejamesstoner.com), [facebook.com/matt.ross.7399](https://www.facebook.com/matt.ross.7399) and [facebook.com/sjcsdtruth](https://www.facebook.com/sjcsdtruth)). Although he denied it, it is clear that the target audience of his videos included children at SPMS. (Ex. B at 4, 10). To complement his performance videos, he also composed and posted videos from what appears to be a home office, in which he would harangue Petitioners and the District with memes and graphics as well as his customary crude and profane commentary. To date, Mr. Ross has over 70 videos and messages targeting Petitioners on Facebook, TikTok and his website.

4. Emails

Mr. Ross also used email to insult, abuse and threaten Petitioners and other District employees. His May 6 email to Linda Carnall was typical:

FOLLOW YOUR F**KING PROTOCOLS IN YOUR PRISON
WORLD YOU STUPID F**KING DUMB C**T or deal with
mine in the real world.

(Ex. A. at 8). Other excerpts of Mr. Ross’ hostile and offensive email correspondence are quoted in the Threats and Intimidation section of this report immediately below and in Exhibit A at pages 7 and 8.

5. Threats and Intimidation

Mr. Ross’ in-person and electronic messaging was hostile, threatening and intimidating toward Petitioners. In his videos, Mr. Ross would depict himself as angry and dangerous – a ninja, a jungle predator, a pimp, a weapon of vengeance:

I'm a ninja. I'll be here, there and everywhere. (Ex. A, at 6).

I'm angry. Yeah, you're right. I'm angry. (Ex. A at 6).

I'm prowling out here like a f**king lion. (Ex. A at 2).

I'm right here. I'm a tiger. I'm a lion. A lion. Bring it. This is a scenario of what I call bring it, b***hes. (Ex. A at 2).

[Y]ou have a giant 6'2", 235 absolute animal of a silverback gorilla dad, giant troll guy out there fighting for you. (Ex. A at 2).

So say I'm a pimp. Linda Carnall would be the top hoe, and I would beat her a** all the time because she was a piece of s**t and f**king just is stupid. (Ex. A at 8).

I'm the f**king sword being swung by the people that can't talk.
I sing the f**king song, a**holes. (Ex. A at 4).

Consistent with that menacing persona, Mr. Ross used extensive threatening and intimidating language and imagery, which obviously were intended to systematically frighten Petitioners and cause them emotional distress, as shown by the excerpts from the transcripts of his online postings and emails attached as Exhibit A. A sampling:

I hate child molesters, mental, physical, emotional it doesn't matter to me. It's all the same. You all ruin children and turn them into angry, confused adults. Well some, not all of us lose our willingness and even eagerness to F**K YOU CHILD MOLESTERS UP any chance I get. (Ex. A at 8).

I really want to know how does it make you feel when someone comes down on you so hard you can't f**king breathe, you can't think, you can't take a breath, you can't sleep, you can't look anyone in the eye? (Ex. A at 7).

Like I was saying I curb stomped you a couple [of times] over the last weekend, just from the traffic and the messages. But, geez, I guess you're just going to have to become a little dark spot in the pavement like when a squirrel runs out in the road. I guess I'm going to be the first guy, and now it's just crazy. Maybe you like the abuse. Maybe you like being bullied. Is that what it is? Yeah, I'm bullying the s**t out of you. (Ex. A at 9).

This is all very reactionary. I mean, that's the thing. Go up to the gorilla cage and make f**king faces at it, and then when it comes smashing through the window, act surprised. (Ex. A at 11).

You cannot handle someone being disruptive? Well how about me, I'm being disruptive. Do something to me you lowlife. (Ex. A at 7).

I'm gonna continue to pound away at that a**. Pound it. Like f**king, you know? You know those big steam drills or piledriver that's how it's going to be. Just f**king pile driving their a**es. (Ex. A at 7).

F**k you lowlife pieces of s**t you think you can molest our children's minds and hearts and we are going to sit back and watch ??? You're like any other predator of children, MY TARGET! (Ex. A at 8).

And I'm targeting very specific people for a very specific reason. (Ex. A at 1).

My target is quite obvious. Targets, they're quite small. And that's why it's surgical, if you will. (Ex. A at 10).

At the end of the day ... these guys, they really need to be part of the past. (Ex. A at 2).

I'm standing here with a bullhorn and a sign. And all I can say is f**king bring it. Welcome to the Thunderdome, b***h. You thought I was playing? You thought it was a game? It's not. Not in the way you're thinking. This is a battle. And this is what it is when you go to kick somebody's a** and just plan it out. Make it right. (Ex. A at 11). See also Ex. A at 1 and 9 ("Welcome to the f**king Thunderdome, b***h").

Let me show you what f**king with people is. (Ex. A at 1).

You guys brought me into the game. You can't hate me for being a f**king animal when it comes to playing. (Ex. A at 2).

Even the crossing guards and everything, they understand my intention is not anything nefarious. Unless you're Linda Carnall, Alexandra Pillay, or James Stoner, then I'd imagine you'd be going a bit crazy. (Ex. A at 3).

James Stoner, Linda Carnall, motherf**king Alexandra Pillay, come out of your cage. St. Johns County School District Board, come out of your cage. Where the f**k are you? Why aren't you standing out here? Why aren't you doing something? Why is it me? Do I have to fight everyone? God d**n, I'm so pissed. (Ex. A at 3).

Think I'm playing? Let me show you the real motherf**king deal. I hide behind nothing. I hide behind no one. I'm pushed forward. That's the difference. That's why I'm here. I'm the f**king sword being swung by the people that can't talk. I sing the f**king song, a**holes. (Ex. A at 3).

Mercedes guy... he's just one of many that I terrify. (Ex. A at 4).

Everybody's like, whoa, this guy's f**king acting crazy. Going nuts. I'm not acting anything. I'm reacting. And back to the silverback gorillas. Man, go watch some videos about them. You'll see why I wear that proudly. (Ex. A at 5).

I mean, what about the teachers that are directly f**king our kids up, you know? How about we start harassing their a**es? Well, okay. I guess, how about we don't start? How about we continue? Because, yeah, I am the ninja beast at this point. As

far as these people are concerned. I feel kind of bad. How many school administrators can a silverback gorilla dad destroy with, like, nuclear bombing precision insanity nerd style without ever really interacting with them other than by email and possibly telephone? (Ex. A at 6).

This is my home, b***hes. You think you can come and f**king stir s**t up in my home and then just go run? No, no, f**k you. What's going to happen is you're going to learn. You're going to learn you're a f**king piece of s**t that has no f**king power outside of your little point. (Ex. A at 6).

I don't need a bullhorn to send my message. I just don't feel like yelling a lot. It's not my thing. However, you brought this on. You made this. You created the fight. If you're afraid, if you're afraid, tap out. Tap out. Get the f**k out of here. (Ex. A at 11).

During one of his sidewalk visits, Mr. Ross took exception to a comment by a motorist who was stopped for traffic leaving the school:

[To a passing motorist] F**k you, you f**king piece of s**t. I'm standing here every day. Where are you? You want to know? Now you know. F**king b***h. That's the problem. Drive-by b***hes. F**king motherf**king drive-by b***hes. I'm not playing. This is my family. This is our kids. F**k this motherf**ker. Come out of your cage, tough guy. Come out of your cage. Your little car cage, just like they got their little cage. They tried to keep our kids in. Come on out. You little b***h. I'll show you. I'll show you. If you want to sit here and talk, we can do that. You f**king think you're a tough guy? Got something to say? Run your f**king mouth. You f**king bring it. I would love it. I would love it. I've been waiting. You think this is just an emotional thing? I love the physical aspect. I love it. Give me a valid reason. (Ex. A at 4).

Mr. Ross' enraged, unhinged reaction was disturbing to Petitioners, who grew increasingly anxious and frightened by his aggressive and unpredictable behavior.

6. Insulting, Dehumanizing, Offensive, Embarrassing and Humiliating Communications Intended to Demean, Dehumanize, Embarrass or Cause Emotional Harm to Petitioners Within the Meaning of Rule 3.21(a)-(e).

Mr. Ross directed shockingly profane, vulgar and offensive invective at Petitioners. According to word find searches of the transcripts of his emails and videos, the word "f**k" and variations of it appear over 500 times, "s**t" over 250 times, and so forth. Exhibit B contains dozens of examples of Mr. Ross' chronic and systematic efforts to demean,

dehumanize, insult and embarrass Petitioners, in clear violation of the law against bullying and harassment of school employees. Examples include:

James Stoner ... a scumbag, liar, weak, stupid. ... racist lazy piece of s**t. (Ex. B at 2).

Then you got Linda Carnall, the f**king principal, total piece of s**t. You got f**king Alexandra Pillay, Vice Principal, complete piece of s**t as well. Just all liars. They just lie and don't even give a f**k. (Ex. B at 2).

I made it a point to show Linda Carnall, Alexandra Pillay, Alexandra Pillay, and James Stoner. The only one without any galls. Hey, the lady's got your galls. ... Get them out of their purse and why don't you show what that looks like? They got the galls. Giant, I mean just like enormous, ridiculous galls. (ex. B at 12).

Look at what Linda Carnall is capable of. I can't come in her prison? Oh, no. Maybe I'll come in her face. (Ex. B at 12).

Linda Carnall is the piss on my rug. (Ex. A at 12).

Please tell me you're sad I'm angry like you condescending c**ts do but I'm guessing you won't. (Ex. B at 8).

Why don't you stand out in the front of the school and say, "We're sorry for being pieces of shit" as you f**king let James Stoner clear his desk out. And, you know, we'll have a little parade. Because it's a start. We're going to start with this Stoner scumbag. But from there, man. Yeah. Who the f**k do these people think they are? I mean, really. They're dumb f**king c**ts. (Ex. B at 8).

This b***h [Petitioner Pillay] had the f**king... I don't want to... I guess the galls. She's got a set of galls like a bull in heat. A female bull. No, I guess that's a cow. Like a cow ready to... I don't know, shoot milk out. Whatever cows do. (Ex. B at 90).

Retaliation: that's cool Carnall you f**king piece of s**t. There's no qualified immunity f**k face (not because anyone wants to f**k your face, it looks like maybe an elephant mistook your "holes" wrong already or maybe was just trying to escape and stuck it wherever. It happens). F**k you lowlife pieces of s**t. (Ex. B at 11)

So say I'm a pimp. Linda Carnall would be the top hoe, and I would beat her a** all the time because she was a piece of s**t and f*****g just is stupid. (Ex. B at 9).

Break a policy. F**k these people. Go post online. Let them do something. Then you can f**k them. The problem is they're gonna be pretty sloppy by the time I'm done. I don't know if you can tell but you can take a turn. There's still gonna be a little bit of a corpse. (Ex. B at 6).

Mr. Ross repeatedly addressed Petitioners Carnall and Pillay as “c**ts,” and “b***hes.” He called Principal Carnall a “hoe,” and said “maybe I’ll come in her face.” He used sexual imagery in describing what he wanted to do to them. (“Pound away at that a**.” Pound it. Like f**king, you know (Ex. B at 7); “Then you can f**k them. The problem is they’re gonna be pretty sloppy by the time I’m done” (Ex. B at 7); and “She’s got a set of galls ... like a cow really to ... shoot milk out” (Ex. B at 9)). The legal significance of using such language is discussed below, at page 14.

CONCLUSION

The Petitioners filed complaints of harassment against Mr. Ross. Based on the complaints and the facts, a preliminary determination was made that there was probable cause to believe that harassment and also bullying had occurred and that they were within the scope of the District’s duty and interest under Rule 3.21 and Florida Statute 1006.147. The investigation was broadened to encompass bullying.

Mr. Ross’ sidewalk demonstrations, emails and website and social postings have been unwanted, systematic and chronic, as contemplated by Rule 3.21(a).

In separate interviews with District investigators, the Petitioners substantiated the case of bullying and harassment against Mr. Ross. They reported that Mr. Ross’ actions towards them have caused them great emotional distress and discomfort. They are concerned for their personal and professional reputations and fear for their safety due to his threatening rhetoric and deranged behavior. His actions have adversely affected their job performance and personal wellbeing. His bullying and harassment have been so pervasive and severe as to create a hostile, intimidating and offensive educational environment at SPMS. They have caused substantial disruption to the orderly operation of the school.

The Petitioners are forthcoming and their accounts of the effects of Mr. Ross’ conduct on them and the school are uncontroverted and credible. In particular, their fear for their safety is reasonable given the violent and threatening nature of Mr. Ross’ rhetoric.

The Petitioners’ claims of bullying and harassment against Mr. Ross stand uncontradicted. Mr. Ross was given notice of the complaints. He was invited to be interviewed to tell us his side of the story and to submit whatever documentation he deemed appropriate in response to the complaints. By email dated June 5, he declined the

opportunity to defend or explain his actions, with the complimentary closing "Go f**k yourself." (Ex. E).

Mr. Ross has not denied that his sidewalk performances, online postings and emails were full of threatening, intimidating, humiliating, insulting and dehumanizing invective, in violation of the bullying and harassment rule and statute. He has not denied that his behavior was so severe and pervasive that it inflicted psychological distress on Petitioners, nor has he denied that he acted with intent to demean, dehumanize, embarrass, humiliate and cause Petitioners emotional harm, within the meaning of the rule.

To the contrary, Mr. Ross freely admitted that he was bullying and harassing Petitioners:

Maybe you like the abuse. Maybe you like being bullied. Is that what it is? Yeah, I'm bullying the s**t out of you. (Ex. D at 2).

What about the teachers that are directly f**king our kids up, you know? How about we start harassing their a**es? Well, okay. I guess, how about we don't start? How about we continue? Because, yeah, I am the ninja beast at this point. (Ex. D at 1).

I just, I appreciate a good troll or a good trolling, I guess. And so, at the end of the day, yeah, I'm trolling the f**k out of these people. (Ex. D at 2).

You cannot handle someone being disruptive? Well how about me, I'm being disruptive. Do something about it you lowlife. (Ex. D at 2).

Not only did Mr. Ross admit that he was bullying and harassing Petitioners, he was proud and happy about it:

And this is what it is when you go to kick somebody's a** and just plan it out. Make it right. It doesn't have to be physical. In fact, this is more fun. (Ex. C at 8).

It feels nice to unload on child abusers. (Ex. D at 2).

And again, all the supporters, everybody out there, keep fighting the good fight. Obviously, I'm not done. This is fun. I'm enjoying it now. (Ex. C at 2).

Having fun. This is awesome. (Ex. C at 2).

See what I'm doing right now? It's not crazy. This is fun. (T. 126).

Mr. Ross' behavior toward Petitioners was sexual harassment *per se*. As the court declared in Katz v. Dole, 709 F.2d 21, 254 (4th Cir. 1983):

[Vulgar and offensive sexual epithets] are widely recognized as not only improper but as intensely degrading, deriving their power to wound not only from their meaning but also from the disgust and violence

The court's comments are apposite here.

It should also be noted that much of Mr. Ross' bullying and harassment directed at Petitioners was carried out on line and constituted cyberbullying and cyberstalking contrary to Rule 3.21 and Florida law.

Based on the foregoing findings and conditions, the Petitioners bullying and harassment complaints against Mr. Ross are sustained.

RECOMMENDATIONS

1. Mr. Ross should cease and desist from further bullying and harassment of James Stoner, Linda Carnall, Alexandra Pillay or other employees of the St. Johns County School District.
2. Mr. Ross should take down firejamesstoner.com and delete all his posts on Facebook and TikTok targeting the Petitioners.
3. The bullying and harassment documented by this report should be reported as required by Florida Statute 1006.09(7).
4. The District trespass order pertaining to SPMS should remain in effect.
5. Mr. Ross should continue to be required to coordinate communications with the school or the District regarding his son through Regional Superintendent Dr. Kyle Dresback.
