**Liability Agreement:** We, the undersigned, fully understand that we are boarding a charter fishing vessel to fish in open water. I understand and assume the risks and hazards associated with inshore and offshore fishing. These risks and hazards include, but are not limited to, the following:

Sun, rain, lightning, sea spray, and any other weather conditions; sea sickness; pitching and rolling; slippery and wet decks; injuries, internal or external, from: boarding and disembarking

the vessel; fish, fishing, fishing tackle, and gear; and the unintentional conduct of any other persons on the boat; death or serious bodily injury.

I understand and agree that I will not hold the Captain, Crew, or Corporation liable for risks and hazards associated with inshore or offshore fishing, and I expressly release them from all such risks and hazards. Moreover, I am not in possession of any illegal substances, and I release the Captain, Crew, and Corporation from any liability whatsoever for any illegal actions taken by myself on the vessel. Based on actions from the above mentioned, Captain reserves the right to cancel or shorten the trip with no refund.

ASSUMPTION OF RISK: I, or I on behalf of my minor child, have been informed of and I understand the various aspects of the Activities are inherently dangerous and that while participating in the Activities I could sustain serious property and/or personal damage, injury, trauma, unwanted contact or harassment by third parties, illness, loss, disability or even death as a consequence of the actions, inactions or negligence of others, conditions of facilities and/or equipment used, and that there may be other risks known or not known to me or not reasonably foreseeable at this time. I further understand and agree that any property and/or personal damage, injury, trauma, unwanted contact or harassment by third parties, illness, loss, disability or death that I may sustain by any means are not the responsibility of my Captain, its affiliates, agents, employees, shareholders, officers, directors, or management, except to the extent of Captains criminal acts, gross negligence or willful misconduct. I, or I ON BEHALF OF MY MINOR CHILD, EXPRESSLY ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, INHERENT OR NOT, AND WHETHER DESCRIBED, ASSOCIATED WITH THE ACTIVITIES FOR MYSELF OR MY MINOR CHILD.

# INITIALS OF PARTY REPRESENTATIVE:

**What IS included in your charter:** your charter will include all the gear, bait, fuel, and ice necessary to supply your day of fishing. Clients are more than welcome to bring their own gear if they'd like, but must notify the Captain prior to trip. Clients should leave coolers for their catch in their vehicles. Typically we are able to supply ice following our return.

**What is NOT included:** Beverages and food are not supplied. We always have a case of water on board, however this is typically reserved for emergency use. If bringing sandwiches, we suggest you place them in ziplock bags to ensure dryness.

**Sea sickness:** Sea sickness can occur to anyone, we suggest that anyone who has even the slightest concern about being seasick takes an over the counter motion sickness medicine prior to departure. It's cheap insurance to make sure you have the most enjoyable day on the water. In the event that you become sick. The Captain reserves the right to shorten or cancel with no refund.

**Alcohol/Drugs:** Beer is permitted on the trip within limited quantities. No liquor, please. Beer MUST be cans, NO bottles are permitted per Coast Guard regulations. Please limit your alcohol consumption. We believe 100% in being safe and responsible on the water. Your Captain and mate will never have so much as a drop of alcohol on your trip. Absolutely NO DRUGS of ANY sort! The last thing I want is to cut the trip short and call the Coast Guard for them to meet you at the dock. Any trips cut short from alcohol or drugs will not be issued a refund. Drunkenness will not be tolerated and will bring an early end to your day. No firearms or illegal drugs allowed on board.

**Cancelation Policy:** Cancellations can be made, with no penalty, up to 15 days prior to the scheduled day of your trip. Your deposit money will be refunded or placed toward a rescheduled trip, whichever you request. Cancellations made between 14 and 8 days of scheduled trip will be subject to 50% forfeit of deposit if trip is not rescheduled to another date. Cancellations made within 7 days of the scheduled trip will result in a 100% forfeit of deposit. No shows on the scheduled charter date will result in 100% forfeit of deposit. Inclement weather cancellations will be determined by the Captain only. Only the Captain reserves the right to cancel the charter with a full refund or reschedule.

**Weather and Seas:** The Captain is constantly following current weather/sea conditions and future forecasting. If the Captain deems seas not conducive to safe fishing conditions, the Captain may cancel the trip. If the Captain cancels the trip, you will be issued a refund of your deposit or credit toward a future booking, whichever you prefer. In many instances we will contact our client prior to a trip to bring you up to speed on conditions. If the client opts to cancel due to seas that may prove uncomfortable, your deposit can be applied to a future trip, not refunded. **RAIN is NOT a reason for cancellation.** 

# INITIALS OF PARTY REPRESENTATIVE:

**Tackle, gear, and equipment:** thousands of dollars in top of the line equipment is invested to make your experience productive and enjoyable. We ask that you take care in handling our gear. e Captain and crew will be there to help keep things problem free and educate you in proper handling. In the event that a passenger proves negligent in the handling of gear and breaks/loses something you agree to pay the replacement cost of such gear. It would be a rare occurrence but a couple examples would be dropping something overboard or throwing something on the deck or stepping on it, causing breakage. Anyone carelessly damaging the vessels or its equipment will be charged for the repairs and replacement. Anglers should dress comfortably and appropriately as the season dictates. Usually the mornings start off cool and the day gets warmer from thereon. Dress in layers. Please no black heeled shoes. Please use non marking shoes.

**Mate/Tips:** Your mate is working for your tip. He/she will be working hard throughout the day, it is "fishing ". Some days are better than others regarding our catch. Please base your tip on the

work that the mate put in to catch fish as some days we'll limit out and some days we won't. 20% of the trip cost is customary for tipping.

Fish cleaning: Fish will be cleaned and packaged to your request.

**Common rules:** Please use your common sense on board, when you are boarding, and when you are disembarking. Boats are not stationary, decks may be wet. Please supervise your children at all times. Please be courteous to other boat owners on the pier. Inappropriate behavior will not be tolerated on the pier. We are not responsible for any of your personal property including fishing rods or any other equipment or property.

We are not responsible for any damage to vehicles parked in the Marina parking lot, you do so at your own risk.

Please retain only the fish you will eat.
