In consideration for the Racer named above ("my child") participating in the Strawberry Derby, I certify that (a) as the legal parent/ guardian of my child, I grant permission for my child to enter the Derby on July 21, 2018, and (b) my child and I have read the above information and that it is true, and that we agree to the terms in this Registration form.

I agree to the following:

- Any and all expenses incurred in transporting my child and his/her car to and from the race shall be at my sole expense.
- Any and all expenses incurred in building or repairing my child's car shall be at my sole expense.
- I certify that my child's car will be constructed in all respects in accordance with the current Official Rules governing the Derby.

I understand and agree that, as a prerequisite to competing in the Derby, my child, together with his/her car, shall have undergone and passed an inspection conducted by Leonard & Strawberry Derby Officials, in its sole discretion, to determine compliance with its rules, spirit and specifications applicable to my child's division in the Derby and the decisions of The Strawberry Derby and its officials regarding qualification and disqualification and compliance with the rules, spirit and specifications applicable to that division shall be final and binding upon me, my child and all other parties. I understand that such an inspection should not be the only safety inspection and that I am solely responsible for the safety of my child's car.

I consent on my behalf and on behalf of my child that any and all videotapes, films, photographs, motion pictures and/ or audio recordings (collectively "recordings") made of my child or my child's voice relative to the Derby may be used by Leonard & the Strawberry Festival, and its representatives, volunteers, employees, officers, officials, sponsors, agents, assignees, licensees and/or successors (collectively "representatives"), in whatever way they desire, including but not limited to television programs and/or any other publicity. Furthermore, we agree that any such recordings shall at all times be the property of Leonard & The Strawberry Festival, which shall have the sole right, title and interest to sell, duplicate, reproduce or make other uses of such recordings as it may desire, free and clear of any claim whatsoever on our part and we therefore waive any right to inspect or approve those recordings.

Finally, I acknowledge that there are inherent risks involved with participation in this activity that can result in (1) injuries or death to me, my children or third parties and (2) the loss of property. I hereby waive and release all claims, rights, causes of action and demands, whether for personal injuries, property damage or any other losses, damages or expenses that I and/or my child may have against the Strawberry Festival, the Village of Leonard, and its agents and employees arising from or in any matter related to my participation in the Derby and/or any activities incidental or related thereto, including by not limited to arising from or in connection with (1) recording of the derby for (2) any injury occurring to myself and my children and/or (3) any other damage or loss of personal property arising from participation in this activity or program.

I further hold the Strawberry Festival, the Village of Leonard and its agents, officers and employees harmless from and against any and all expenses (including actual attorneys' fees), claims, suits, injuries, damages, losses, judgments and consequential losses and damages, sustained either by reason of or arising out of or in any way connected with my participation in the Strawberry Derby. The undersigned further agrees to defend and indemnify the Village of Leonard and its agents, officers and employees from and against any claims made by any party(ies) for any and all damages and losses of any kind arising from my participation in the Strawberry Derby, including any claims made by my child(ren) after they attain the age of 18 years.
