

# COMPLETE ELSEVIER TRAINING

## Purpose

This document will prepare you to complete an online learning activity created by Elsevier. CareLearn Washington has content from three different vendors – DSHS, Elsevier, and SkillSoft. Each vendor builds courses a bit differently from the others. For example, most of the courses from Elsevier require you to complete a number of separate lessons per course. Most SkillSoft courses are just a single training. Some courses require you to register for the course, and others do not. In this document I will provide an example of searching for a course developed by Elsevier, and completing that training.

## Process

1. Log into CareLearn. If you are already in CareLearn, click the **Home icon** at the top of the **interface**.



2. Locate an Elsevier course. In this example I will use the library. Click the **Library icon** located in the **Header menu**.



3. When you click the library icon, you will see a **slide-out menu** on the left of the **interface**.



\* Note that the image above may not reflect the current state of the system.

4. Click the **Elsevier Library**. Do NOT click the **>** icon to *expand* the library, just click the library name itself. All Elsevier courses will appear (in alphabetical order by default).

- CRCI: Cultural Competence in Mental Health Service Settings**: CRCI: Cultural Competence in Mental Health Service Settings is comprised of 12 Lessons. All lessons must be completed (in order) to earn CE credit. You do NOT need to finish all of the lessons. Type: Simplified Curriculum (mobile), Duration: 1 Day 1 Hour, Course Code: ELS0104. Includes a 'SELECT' button.

5. For this example I am going to be taking the course titled **CRCI Understanding the HIPAA**. In the image below, notice the **Course Code**. Each course has a unique course code, and any training developed by Elsevier has a code that begins with "ELS." If I click the **Select button** next to that course I will see the following options:

#### What are those acronyms at the beginning of the Elsevier course names?

Elsevier organizes training into categories. They refer to those categories as *Colleges*. The acronyms identify which college the course belongs to.

- **CRCI** stands for **College of Recovery and Community Inclusion**
- **CPAC** stands for **College of Personal Assistance and Caregiving**
- **PCC** stands for **Person-Centered Counseling**

- Some courses let you start them without registering first. This course will require me to register. Rather than doing so, I will click **View Details** option. That will display more information about the course (the same information you would see if you were to click the course title in the image above). Take a moment to review the information available about this course.

Notice on the left side that this course has three lessons. They must all be completed and in order.

**Most Elsevier courses have a number of lessons that have to be completed in full (and in order) to complete the course.**

In the **Full Description** section you can see that this course will award 1.5 hours of Continuing Education (CE) credits. **You will only receive CE credits when you have successfully finished the last lesson in this course.**

In the **Course Header section** you can see a **Completion Status indicator**. This will show your progress as you complete the lessons in this training.

- Click the **Register button**. When you register for a course with multiple lessons, the system will automatically register for each lesson in that course.

Notice that you are now looking at the **Activities tab**. It shows that I am registered for each of the 3 lessons, and each one has a **Start button** next to it. Above the courses you can see a message that reads: *You need to complete 3 of the 3 activities below to complete this program.*


8. Click the **Start button** next to the first lesson. This will open a new browser window. Your previous browser window will say: *Online activity is in progress. Do not close this page. You will be automatically redirected on completion.*

**Do not close either browser window when you begin training.**

9. **Maximize** the browser window that contains the course content. That means you should click the little square icon at the top right of whichever browser window has the Elsevier logo showing.



10. Now that window is using the full size of your monitor. Each Elsevier course will look and behave very similarly. The **Introduction page** will include a number of **links** with information about the course. The links will open in a third browser window that can be closed after viewing. For example, there is a link that will describe each of the lessons in the course, and the learning objectives. You will also find a **Glossary**.

11. Click the **Start the Lesson button** that appears on the bottom of the Introduction page.

Elsevier courses have a **Header section** of their own. It includes a course menu, a note-taking tool, a link to the lesson's test, and exit button, and a help icon.

- The **Lesson Menu** can only be used for navigation once you have seen each page of the lesson.
- My Notes** will open a new window in which you can take notes. Your notes will carry forward with each page you view.
- The **Lesson Test** is only available after you have finished the last page of instruction.
- You should only click the **Lesson Exit** icon after you have completed the test.
- The **Help icon** will show you instructions developed by Elsevier.

Many pages include narration. To listen to the narration, click the play button on the embedded **media player**.



If you click the CC button in the media play, a transcript will be displayed in its own window. You can close the transcript when you are finished.



- Only after you have viewed and interacted with each page of the lesson will the Lesson Test be available to you. When you are ready, click the **Lesson Test** icon in the **Header section** of the page.
- You will next see some test instructions. **Note that each test requires you to score 80% to pass.** Once you complete the test, you will receive feedback about what you did and did not get correct. At that point you can exit the lesson. If you score less than 80% on the Lesson Test you will not get credit for the lesson, which means you will not get credit for the course. **You can restart the lesson to re-take the test.**

You must score 80% or better to pass each test  
If you do not pass the test, you can re-start the lesson and take it again

14. On the test instructions page you will find another icon to begin the test. Click it.



15. Answer each test question. When you are finished, click the Submit Test button at the bottom of the page.

16. Review the feedback. You will be shown your score and each question along with your answer.



17. Note that once you have passed a test in Elsevier you may see information about their certificates. These are NOT DSHS certificates and are of no value to you. **Any diploma awarded by DSHS will be available on your Training Transcript.**

18. Click the exit icon at the top-right of the page to exit the lesson. **Doing so will close the web browser window that included the lesson.**
19. Your other browser window is still available. **Make sure you do not close it.** When you started the lesson it had a message that said: *Online activity is in progress. Do not close this page. You will be automatically redirected on completion.* But once you exit the lesson that page will change. Now it shows you results. Note in the following example that I scored a 70% which is NOT a passing score. So the **Lesson Status** is **Incomplete**. A lesson status of Incomplete means I do not get credit for the lesson and will have to retake it.

21. If you successfully completed the lesson your **Lesson Status** will be **Attended**, your **Course Completion Status** will be updated, and you can start the next lesson in the course. However, if you did not pass the test (as in my previous example, your **Lesson Status** will be **In Progress**, your **Course Completion Status** will NOT be updated, and you will have to restart the lesson. If you restart an Elsevier course that you have already completed, the Introduction page will include an option to take the test. We recommend you review the course content before doing so.
22. Start, test, and complete each of the lessons in the course. When you have successfully completed the last lesson, the **Course Activities** page will show your **Course Completion Status** to be 100% and your **Course Status** will be **Attended**.

- If an Elsevier courses awards **Continuing Education (CE) credit**, you will NOT earn that CE until you have successfully completed all lessons in the course. Make sure you can do so before your next birthday, so the credits will be applied in time.
- Elsevier lessons have to be completed in full and in order.
- All lessons include a test. You must score 80% or better to earn credit for the lesson.

## Troubleshooting Elsevier Training

The Elsevier training content isn't perfect or bullet-proof. You may experience some problems. If the course content is very slow, you may want to exit the course and try again later. The Elsevier content is on another server, and they may be having problems. If you re-start training, the system will remember where you left off.

You may also experience some of the problems showing in the image below. Note that there are 4 **vertical scroll bars** showing on this page. Some pages have multiple parts of the page which can be scrolled up or down independently. This will happen most often when you are viewing content on a small screen (monitor). It will happen less often when you use a larger screen. If your browser window isn't **maximized**, start by maximizing the screen. Make sure you scroll up and down with each scroll bar to see all of the content on the page. Start with the inner-most and work outward.

The second problem showing in the image below is that there are some graphics covering text. If you ever see an example of that, try maximizing and minimizing the browser window, scroll using any available scroll bars, and try moving back and forth between the next page and the current page.

## Notes

### Glossary of Terms (just the most useful)

<b>Course Code</b>	Each course in CareLearn has a unique course code. Elsevier codes start with ELS, and SkillSoft codes start with SKS_. Any other code indicates the course was developed by DSHS.
<b>Course Completion Status Indicator</b>	Courses that include multiple lessons, will use this to show your progress. As you complete lessons the indicator will change to reflect that progress.
<b>Elsevier Header section</b>	Each Elsevier lesson has a header section. There you will find the Test and Exit icons.
<b>Elsevier Introduction page</b>	Each Elsevier lesson has an introduction page with links. It will also include the Start Lesson button.
<b>Expand / Contract Header menu</b>	Many menus can be expanded and contracted to show or hide their more information. At the top of most every page. Contains the <b>Home, Search, and Library</b> icons.
<b>Interactions Interface</b>	Anything you can interact with in a course or lesson. They are clickable areas in the lesson.
<b>Lesson / Course Status</b>	The area of the screen that CareLearn uses.
<b>Maximize/Minimize</b>	Indicates <b>In Progress</b> or <b>Incomplete</b> (depending on where you are viewing it) until you have successfully completed the lesson or course. It will then change to <b>Attended</b> or <b>Passed</b> .
<b>Media player</b>	When you click a web browser's Maximize button, it will use the full size of your display. Some pages include embedded media players. Use the controls to start/stop/pause the media. You will also find a button for closed captioning if available.
<b>Navigation buttons</b>	Previous and Next buttons to navigate within a course or lesson.
<b>Slide-out menu</b>	A menu that slides in and out of the current page.

### Elsevier Training Quick Reference Guide

- Find courses from Elsevier by clicking the Library icon and then clicking Elsevier Library.
- Click the course title that interests you and review its description and lessons.
- Click the Register button in the header section. It will register you for ALL lessons in the course.
- All lessons must be completed, and in order.
- Click the Start button next to the first lesson.
- A new window opens, do not close the new window or the previous browser window.
- Click the Start the Lesson button that is at the bottom of the lesson Introduction page.
- Move through the course using the Prev and Next buttons, and interacting with the content.
- When you have reviewed all content click the Take Test icon.
- Review the test instructions and click another Take Test icon.
- Answer all questions and click Submit Test.
- Review the feedback and click the Exit icon.
- If you score below 80% on a test, exit the lesson and re-start that lesson.
- When you have successfully completed all lessons you will get credit for the course.
