This fee schedule is intended for new engagements and may be adjusted based on case complexity, scope, urgency, and anticipated testimony requirements.

### STANDARD FEES

### EXPERT REPORT FEE

The **\$2,500 report fee** includes: analysis and interpretation of relevant data and materials; consultation with retaining counsel; preparation and delivery of a written expert report; and reasonable availability for questions related to the completed report.

### EXPERT ANALYSIS & CONSULTATION

Expert analysis, case consultation, record/data review, and other consulting services that **do not result in a written report** are billed at **\$250 per hour**, in **15-minute increments**.

### TESTIMONY

**Half-Day — \$2,500:** Testimony or other expert-witness services lasting **4 hours or fewer**. **Full-Day — \$5,000:** Testimony or other expert-witness services lasting **more than 4 hours and up to 8 hours**.

### ENGAGEMENT TERMS

**Scope:** Fees are established based on the scope and requirements of each engagement. Specific services, anticipated time commitment, and applicable fees will be confirmed in a written engagement agreement.

**Travel:** Reasonable travel charges originating from **Sioux Falls, South Dakota** will be billed separately. Travel expenses may include transportation, lodging, meals, parking, and other reasonable travel-related costs.

**Billing:** Hourly consulting services are billed in **15-minute increments**. Invoices are issued as work is performed and are payable according to the engagement agreement.

**Testimony Scheduling:** Testimony dates and times are reserved upon confirmation of the engagement. Additional scheduling, preparation, and cancellation terms may be established in the engagement agreement.

**Professional Independence:** Karyon Genomic Strategies maintains professional independence and does not condition compensation on the outcome of a case.
