### 5. PROPOSED POLICY: Lateness To and Absence From Rehearsal

Students are expected to be present at, and early for, all rehearsals and performances. Absence from a rehearsal will, in most cases, preclude the student from any further participation in the all-state ensemble. This decision, which will be based upon the best interest of the ensemble, will be reached in coordination with the ensemble organizer, the student's director, and the TCCBDA President. Likewise, students who are late to rehearsals may face chair reduction or removal from the ensemble.

### 6. PROPOSED POLICY: Removal From An Ensemble

Students who are removed from an ensemble due to egregious behavior (as determined by TCCBDA) are no longer a participant in TCCBDA or TMEA activities. They must surrender their TMEA nametag and are not allowed to remain in TCCBDA housing. The student becomes the sole responsibility of the sponsoring director, who must arrange and pay for immediate transportation home.

#### E. New Business:

- 1. TCCBDA will have a booth in the lobby of the convention exhibit hall at TMEA.
  - a. TMEA will comp the booth if we join as an Institutional Member (\$55).
  - b. TCCBDA President will be responsible for scheduling members to work at the booth.
- 2. Proposal to use portions (cuts) of the All-State Jazz audition etudes
  - a. Cuts would be chosen by the Jazz Ensemble Organizer.
  - b. Desire is to increase participation in Jazz Ensemble auditions

### 3. PROPOSED POLICY: Forms of Payment to TCCBDA

Student checks are no longer acceptable for any type of payment to TCCBDA. Preference is a) Institutional check, b) Institutional P.O. #, or c) money order. If a director submits a personal check for payment, s/he accepts full responsibility for any returned check fees that might be levied.

- 4. Initiation of an annual Institutional Membership Fee
  - a. The Institutional Membership (IM) fee will be paid with submission of audition tapes and fees.
  - b. Schools who submit no audition tapes will not pay an IM fee.
  - c. A school pays the IM fee when submitting 1 or more audition tapes, whether for the Symphonic Band or the Jazz Ensemble. The fee is paid only once each year.
  - d. The audition forms will be modified to reflect the inclusion of the IM fee.
  - e. This fee will generate an average of \$500 each year.
- 5. Necessity of Audition and Participation fee increases
  - a. Increase of expenses has caused higher expenditures than anticipated.
    - i. Hotel only comps 1 room and only for 3 nights
    - ii. Clinician's contract now in place will limit some expenses
      - 1. specifies exact travel allowance
      - 2. specifies meal per diem
  - b. According to the Treasurer's Report, we no longer cover our expenses through our income, which is based on audition and participation fees.
  - c. Current and Historical fee increases by ensemble:
    - i. Symphonic Band:
      - 1. Audition fee changed from \$5 per student to \$5 per tape in 2005
      - 2. Participation fee currently \$20; changed . . . ?
      - 3. Current average annual income generated by Symphonic Band
        - a. Audition Fee: \$1,010 (from 202 tapes)
        - b. Participation Fee: \$1,900 (from 95 participants)
    - ii. Jazz Ensemble
      - 1. Audition fee changed in Fall 2004 from \$5 per student to \$10 per student
      - 2. Participation fee currently \$30; changed . . . ?
      - 3. Current average annual income generated by Jazz Ensemble
        - a. Audition Fee: \$430 (from 43 students)
        - b. Participation Fee: \$570 (from 19 participants)
  - d. Proposed new fee structure will produce \$800 over projected expenses each year.
