

September 25 & 26, 2021 Food Vendor Application

Down by the river we'll have another great shindig this year to showcase the first-born art of Appalachia. Art and food vendors have been hurt but are helping our economy and our lives return to normal. So, we salute you, and we want to help in some small way. This year, **the vendor fee will be only \$30 for two full days.** Vendor space will be 12 x 12 with two feet between spaces. Double spaces and food trucks will be \$50.

We are looking for traditional mountain foods and those from other cultures that make up the North Georgia family. We're especially interested in foods like greens or beans with cornbread, fried apple pies or dumplings, fried chicken, hamburgers, tacos, roasted corn, peanuts, funnel cakes, etc.

With lower vendor fees, we'll depend more on "gorilla marketing" (cards for you to hand out, social media, etc.). So, we need to know as soon as possible if you plan to join us. *NEW*- Early fee payment (by July 19) will assure you the best space, the most publicity, and a *free T-shirt*.

Outside spaces that are not food trucks must be covered. Fees will be returned (minus \$5) to anyone who is not accepted. To avoid too much duplication and provide traditional foods, we need your application as soon as possible and we may ask if you can eliminate some items from your offering. Include with your application a photo of your booth or truck or direct us to your website. Digital photos are acceptable with emailed applications. High resolution photos may be used in festival publicity. We have electricity available, but it will be limited so please apply early if you need it. Only quiet generators can be used.

Food vendors must have a trash can for customers and at least one table with four chairs. Signs and displays must be within the paid space, and sales cannot be made away from your booth or truck. We'll provide the music so don't bring your radios, CDs, etc. No animals are allowed in food booths with the exception of certified service dogs with documentation. Vendors cannot smoke on the festival site or pass out political handbills. No individual raffles. Each vendor is responsible for sales tax collection and reporting.

You must provide a certificate of insurance listing Dancing Goats FolkFest as additional insured. Security will be provided Friday and Saturday nights, but equipment, signs, etc. must not be left outside your tent. Dancing Goats is not liable for anything broken or stolen (see agreement below). All vehicles must be parked in designated vendor parking, which is on site.
