1. Reservation Fee Purpose

I understand that my \$_____ reservation fee secures my place within the selected Blissful Paws Pomsies litter.

I understand that this reservation fee does not reserve a specific puppy and does not guarantee a specific size, coat color, eye color, markings, or other cosmetic traits.

2. Puppy Selection Process

I understand that Blissful Paws Pomsies carefully evaluates each puppy as they grow and that puppy development, structure, and individual needs may be considered throughout the selection process. I understand that I will select from the available puppies within my reserved litter during my designated selection time.

I understand that Blissful Paws Pomsies reserves the right to hold first and second pick placeholders from each litter when necessary. These placeholders are not guaranteed and will only be used when needed to support the continued improvement and future development of the Blissful Paws Pomsies breeding program.

3. Pricing and Cosmetic Traits

I understand that all Blissful Paws Pomsies are priced equally regardless of coat color, eye color, markings, or other cosmetic characteristics \$_____ (\$_____ + 8.25% sales tax) . I understand that the final balance will be due when I pick my puppy at 5-6 weeks of age.

I understand that my reservation fee secures my place within the litter and does not reserve a specific puppy. I understand that Blissful Paws Pomsies' reservation process is intended for families who are open to all possibilities within the litter, including variations in size, coat type, coat color, eye color, markings, and gender.

4. Reservation Fee Terms

I understand that my reservation fee is non-refundable and non-transferable between litters. I understand that Blissful Paws Pomsies does not accept reservations for unborn puppies or future litters. If I choose not to continue with my selected litter, my reservation fee will be forfeited.

5. Pet Home Placement

6. I am aware that puppies can have certain common ailments upon coming home.

Urinary tract infections, parasites, ear infections and allergy issues are all common. While we routinely deworm and monitor for potential UTIs and ear infections, sometimes the stress of leaving the breeder causes issues to flare up. I understand it will be my responsibility to treat and care for my new puppy once they leave Blissful Paws Pomsies. I understand that puppies can have certain ailments and I agree to ensure they get the proper care and medication, if needed.

7. Puppy Pickup and Transport

Option C – DFW Airport Puppy Handoff Service Fee: Complimentary

I understand that Blissful Paws Pomsies offers a complimentary airport handoff option at Dallas/Fort Worth International Airport (DFW) for families traveling to receive their puppy.

I understand that all travel-related expenses are my responsibility, including but not limited to:

- My personal airfare or transportation to and from Dallas, Texas

I understand that prior to puppy handoff, I must provide proof of my puppy's approved in-cabin airline reservation. Blissful Paws Pomsies will not release a puppy for travel without verification that the puppy is scheduled to travel safely in the cabin with the family.

Option D – BPP In-House Flight Nanny Service

Service Fee: Starting at \$750

Due to the limited availability of this service, the BPP In-House Flight Nanny Service fee is due in full at the time of reservation and is non-refundable.

I understand that any changes requested by the family, including changes to travel dates, flight arrangements, scheduling, or airport location, may require additional fees and availability confirmation before a new travel arrangement can be secured.

I understand that Blissful Paws Pomsies offers an In-House Flight Nanny Service utilizing approved BPP family members only. Outside flight nannies or third-party transport services are not permitted.

I understand that BPP In-House Flight Nannies do not fly standby. All flights must be purchased as confirmed reservations to ensure the safety, reliability, and timely delivery of my puppy.

I understand that I am responsible for all costs associated with this service, including but not limited to:

- The flight nanny's round-trip airfare
- My puppy's in-cabin airline fee
- Required airline-related fees
- The BPP Flight Nanny Service fee

I understand that all fees associated with the BPP In-House Flight Nanny Service are non-refundable once reserved.
