Manuscript Guidelines

IFOTS invites submissions for its issues on a continuing basis. The journal accepts unsolicited manuscripts. Articles must be written in English and submitted in Microsoft Word™ format. Authors should follow the Publication of the American Psychological Association (APA) 7th edition style in written submissions. The length of the manuscript should not exceed 5500 words or 15 pages.

Submitted manuscripts must fulfill the following criteria to be considered:

- Have not been previously published. Revisions of prior publications are considered
- Are not currently under review by any other journal
- Are original materials to which the author/s can assign copyright
- If English is not the author's first language, a professional copy-editing of the manuscript has been completed prior to final submission.

Notification of acceptance (after blind review) by	September 15
Final manuscript submission	September 20
