- This cat/kitten must be spay/neutered between 6-9 months of age in order to quality for Health Guarantee.
- > Spay/neutering your cat will reduce your cat's allergen level.
- > If you want/need your cat's official registration papers (TICA Breeder Slip), please make a request at the same time when you will be submitting to me proof of castration/spay/neuter.
- Under no circumstances this cat/kitten can be DE-CLAWED, or sold/leased, or given away to any pet shop or any research labs.
- ➤ This kitten is guaranteed to be sound of health upon arrival for the period of five(5) days from the day of purchase. It is the responsibility of the Buyer to take the kitten for a vet-checkup at their expense within that time. It is recommended that the new kitten is kept in quarantine during this time and the Buyer accepts all responsibility for any spread of an illness to other animals. If it is found to be medically deficient with an "untreatable" or "lifethreatening" problem during this time, it must be reported to the Breeder immediately. Upon its immediate return, it will be replaced with another kitten of equal value within six(6) months, as available. A health report issued by licensed veterinarian, indicating that this kitten indeed is ill with a "life threatening", or "untreatable" disease should be provided to the Breeder at the

time of return. This kitten cannot be returned after the guarantee period had expired and or/if it has been exposed to another kitten/cat which has not been currently tested for FELV, FIP, or ringworm. It is responsibility of the buyer to provide immediate veterinary care if this kitten is showing signs of illness or distress and failure to do so will render any guarantee null and void.

- Dirthday. If this kitten dies and said defects up to their 2nd birthday. If this kitten dies and said defect evidenced in an autopsy report, provided by a licensed veterinarian, we will replace this kitten with another of comparable quality and value, as available, at the discretion of the Breeder. Once a replacement kitten has been offered to the Buyer, and the Buyer declines to accept that kitten, then this contract is considered fulfilled and the Buyer surrenders all rights to claim for another kitten. Breeder will not replace any kitten/cat that has not received adequate and appropriate care from its new owner. NO CASH REFUNDS.
- > We do not recommend vaccinating this kitten with the FIP or FeLV vaccines. If FIP or FeLV vaccines is given to the kitten at any time, the entire health guarantee becomes NULL and void.
- > If Rabies Vaccine is given to the kitten before 5(five) months of age, the entire Health Guarantee becomes NULL and void.
- When possible, always opt for three year vaccine instead of one year.
  It is much healthier to a cat not to be vaccinated frequently/yearly.
- > Remember, when it comes to vaccines, "less is better".
- > Buyer agrees to pay all court and attorney costs if this contract is litigated, and if any suit shall be filed. This contract is legally binding to all parties involved. It applies to the Buyer and Breeder in this transaction and is non-transferable to other parties.
