## Important information to note:

\*The programs require a fee to complete. Call the number for your location to confirm the program fee.

\*Tarrant County Community Supervision Corrections Department (CSCD) also known as Tarrant County Probation Department requires that all TIP courses meet the following minimum requirements:

1. TIPs program must meet 10 total hours of counseling (eight (8) in a group setting and one (1) hour intake and exit sessions, and
2. Group sessions can meet once a week for eight (8) weeks or twice a week for four (4) weeks.

\*Fast-Track Theft Intervention Program such as one (1) or two (2) day programs are not approved as a condition of probation: check with your probation officer before signing up for ANY program. Completing a program not approved by CSCD/probation may mean you have to complete another program. CSCD/probation accepts no responsibility or fault for you choosing a program that is not pre-approved.

\*If completing the program as part of a plea negotiation packet or as part of a memo agreement, talk with your attorney to confirm which programs you are completing as part of the packet or memo agreement.

\*At the completion of the program you will receive a certificate of completion. Provide the certificate to your probation officer if you are completing as a condition of probation. If completing as part of a plea negotiation packet or memo agreement, provide the certificate to your attorney.
