Hotel Packages Cancel/Refund Policy:

Once deposited the hotel booking is nonrefundable.

Shore Excursion Company:

Please consult your shore excursion company for their cancel policy which is independent of All Genre Travel.

Cruise Cancel/Refund Policy

The cancelation policies for each years gothic cruise varies by date, cruise line, length of cruise, the type of fare booked and increases as a booked sailing date draws closer. In addition, the cruise line penalties are separate from the agency cancel fees. Please keep in mind this a festival type event. Normal cruise line cancelation penalties do not apply. For that reason, we have listed the cancelation penalties below by cruise year.

However, all booked items are 100% nonrefundable within 120 days of sailing.

Please consult the tables below for the year you are sailing for your cancel and/or name change fee rules.

Exceptions:

There are rare times when exceptions are made to above policies, such as world pandemic. These kind of exceptions are not guaranteed and can vary by person and/or incident. However exceptions cannot be made for death, sickness, budget issues or accident. Please consider travel insurance to protect your vacation dollars when purchasing the gothic cruise as this is what travel insurance is for.

Remember, if you chose to roll your 2020 Gothic Cruise over to 2021 instead of the refund option last year, your cruise is nonrefundable. HOWEVER. If MSC is forced to close our sailing this year due to

closed borders or pandemic, you will be automatically moved to next year as will your insurance. At this time we have not been made aware of any further refund options beyond June 30 2021.

Everyone can still make name changes as needed regardless if your cruise was rolled over or you booked a new one.
