## **Implementation Starts**

The PSUP Project on Portion 939 has started. The State has granted the approval for Planning Permission. This means the Sub-Division Plan for Portion 939 is approved and implementation now commences.

In preparation for the eminent survey and construction work to commence, DSI put out an internal Bill-Board for block-holders to consult and plan in advance.

Furthermore 'Stop Work and Demolish Notice' was issued on 08th of March 2023 followed by specific Notices to individuals who are in breach of this planning permission orders. The Notices are enforceable by Law thus police has been assisting in the enforcement. Section 99 of the National Physical Planning Act 1989 imposes a penalty of K4,000.00 for offenders/non-compliance.

### **Awareness & Communication**

On going awareness is being carried out within the Community jointly by local Associations mainly —Portion 939 Southern Zone Block Holders Association and DSI. Four (4) awareness and community meetings were conducted since 26th of February 2023. Other two sister Associations of Kusambuk and Kerewaka are also engaged in project awareness with their respective members.

Community Meetings usually happens on Sunday 3pm.

Leaders usually go around the Portion making public announcement using loud hailers 24 hour before Meeting and 2 hours before Meeting times. Attendance has been good so far though more people needs to turn up.

This PSUP Project intends to benefit all citizens of PNG including the current residents of Portion 939.
