# Omaha provides worthwhile experience for Lakes & Prairies District Exchange Fall Conference

The Exchange Club of Omaha welcomed over 40 registrants at the DoubleTree by Hilton Hotel in downtown Omaha for the Lakes & Prairies District Exchange Fall Conference, Sept. 30 to Oct. 3, for socializing, sightseeing, and Exchange activities.

#### One Nation Under God

Exchange events took place early Saturday, Oct. 2, with the One Nation Under God breakfast. The keynote speaker was Bill Williams, who with his wife, Evonne, founded Patriotic Productions in 2011. Their mission is to honor our military from today's war on terror, going back to World War II, including those who have died while serving the United States.

Prior to 2011, the Williams' began organizing Honor Flights to fly Nebraska veterans of WWII, Korea, Vietnam, Iraq, and Afghanistan back to Washington, D.C., to honor those veterans, and to see the memorials of those conflicts. To date the Williams have raised over \$3 million, making it possible for 3,500 veterans to participate in one of a dozen flights to Washington, D.C. Williams described the appreciation of veterans and their families to have that experience.

Another focus of Patriotic Productions is <u>Remembering Our Fallen</u>, a traveling photo memorial to honor our nation's fallen since 9/11/2001. "The mission is so these men and women are not forgotten," said Williams.

There are 19 state-specific memorials including Nebraska and Iowa, and a national memorial was unveiled in 2017 at the steps of the Lincoln Memorial in Washington, D.C., and has since traveled to over 75 cities in 35 states.

Bill and Evonne this year organized

#### FILE YOUR 990-N FORM!

Clubs are at risk of losing their tax-exempt status if they have not filed a Form 990-N information return (or other required form) during the last three years. Form 990-series returns and e-Postcards are due by November 15th each year. Additional information is available from the IRS site, <a href="https://www.irs.gov">www.irs.gov</a>.

All clubs are instructed to send a copy of the e-postcard to the finance department in order to ensure that all clubs have met the IRS filing requirements.



After the death of her mother in 2016, McKenna was on a spiral down as a 12-year-old, confused and not sure where life was taking her. She felt like an outcast at her school, and fell into a deep depression. With help from her dad and therapists, McKenna began to turn her life around and became a true role model for her younger sister. As a result, she became very active in school and excelled in her affiliations with FCCLA (Family, Career and Community Leaders of America). At the same time, McKenna began to really develop her art by lending her skills to design and paint murals for the school. McKenna is attending Central College in Pella, Iowa, with plans to major in biochemistry with pre-optometry prerequisites. She is committed to giving back to the community, joining clubs, and volunteering in several different capacities.

McKenna addressed those in attendance for the luncheon for the "wonderful honor," and thanking those who have been part of her life.

Nelson, the daughter of Jacob and Brenda Nelson of Waseca, is a 2021 graduate of Waseca High School, and was sponsored by the Exchange Club of Waseca. She is attending South Dakota State University in Brookings, South Dakota, and was unable to attend the luncheon, but provided a video thanking the district for the award, and read her essay submitted for the award. While athletics was important to Megan during her high school career, she stated serving as the drum major of the marching band was her greatest leadership experience, especially during the pandemic. At college, Megan is participating in the honors program majoring in human biology with an emphasis in pre-med. Her plans are to go to medical school, and eventually be a family doctor.

The luncheon's keynote speaker was Kevin Kush, who has been involved with coaching and teaching for over 30 years. Kush spent 21 years working with at-risk youth at Boys Town in Omaha, Nebraska. He compiled a remarkable record of 164 wins and

just 58 losses with 13 of those teams finishing in the top 10. He now speaks full time to a variety of groups including teachers, youth organizations, and companies. In 2005, Kush was featured on ABC World News Tonight as their "Person of the Week."

Kush is the author of three books, "The 100 Yard Classroom," "Competing with Character," and "A Piece of the Puzzle — Eight Traits of a Quality Teammate," which he addressed during his remarks.

"Everyone affects team morale," said Kush, as he reflected on accountability in doing your job, don't make excuses, and don't blame others.

He reflected on the setbacks in life and termed them, "What an opportunity," as he reflected on his own son's inability to participate in athletics due to injury, but found the opportunity to be the best academic student he could be, and how that impacted his choices as an adult. Kush's remarks were well received during the luncheon.

#### Afternoon Breakout Sessions

The first afternoon breakout session was "7 Steps to Increasing Engagement," by Life Coach Susan Koenig. "What is your why?" asked Koenig regarding engagement as often to become involved you're "Willing to be uncomfortable to make a contribution," said Koenig whether you are donating your time, money, or both.

For those seeking to find others for

engagement whether it is participation in a project or to join a group or club, find the strengths of those individuals, "You work to make it easy for them to say yes," said Koenig. "Be curious about their interests."

As for participation in anything, Koenig stressed the importance of making it enjoyable and invite feedback, "Anything not enjoyable is not sustainable."

Koenig encouraged the impact of acknowledging sincerely. She noted a thank you is for what someone did. Acknowledge is what people are being, and as a group activity revealed acknowledgment is from the heart and has more sincerity.

The final breakout session was "Going for Gold," a panel discussion on making clubs vital, vibrant, and fun! The panel provided experiences that led to club success whether it was club building, retention, or a project and/or fundraiser that went well or has led to consistent success. A common theme that came up was the importance of a personal approach. You can send out mailers, reach out through social media, but the greatest success is achieved with personal contact, which has been a challenge (District Conference continued on Page 4)
