WHEREAS, said Commission waived the requirement for notice and hearing pursuant to Section 56261 of the Government Code,

NOW, THEREFORE, BE IT RESOLVED that:

- 1. County Service Area No. 13 Alpine Meadows be, and it is hereby, formed to provide all extended county services as described in Government Code Sections 25210.4 and 25210.4a.
- The boundaries of this County Service Area shall be as described in Exhibit "A" and as shown on the map attached hereto as Exhibit "B".
- This Board shall, from time to time, establish appropriate rates and charges for extended county services furnished within the County Service Area.
