Professional artist sought for new Hattiesburg public art project

for Public Art has announced a Call for Artists to design and execute an exterior mural titled "Your Life Matters." The project will be located at Ebenezer Baptist Church on East 8th Street in Hattiesburg, MS. Artists with professional experience in public art or painting are invited to respond to the call.

This new addition to the series of public art pieces commissioned through HAPA so far in 2020, "Your Life Matters", will be a lively, positive mural focused on the impact people have on those around them.

The completed project will measure approximately 11.5 feet high x 33 feet wide and be placed along the exterior of Ebenezer Baptist Church. The mural will face the newly restored East 8th Street basketball and tennis courts and also be highly visible from Chain Park, Hattiesburg's 37-acre Facebook and Instagram pages public park along the Bouie

JANS – Hattiesburg Alliance River. The prominent location will allow the mural to be enjoyed by tens of thousands annually.

The purpose of the mural will be to illustrate the impact people have on those around them. Ultimately, it will convey the message, "The world needs the best of you...because you matter." Professional artists, both locally as well as those from across the state and nation, are encouraged to submit designs.

The final design selection will be based on artistic merit, creativity, demonstrated ability, technical knowledge, and the artist's interpretation of the theme.

Working it! Jackson welcomes new curator at art museum

It was destined to happen -aconversation about pop culture, poverty, being Black in a cre-

ative world, and the importance of art. That is exactly what Rvan N. Dennis and I dis-

cussed recent-Amia

Edwards ly. She is the new Chief Curator and Artistic Director of the Center for Art & Public Exchange (CAPE) at the Mississippi Museum of Art. My title is a little shorter when it comes to my capacity at the art museum: Community Advisory Board Member. It is safe to say we have a few things in common. The main thing is the love of art.

My first question about the

world of art? What is a curator? Ryan explained it with ease: "It is someone who cares for the art – a kind of a custodian of the art. I also am supportive of the artist's vision to the public."

Dennis and her family are new to the Jackson Metro Area and she packs an impressive resume. After leaving New York as the Artist in Residence Manager at the African Art Museum (now the Africa Center), she then joined Project Row Houses in Houston, Texas as Curator and Programs Director.

I researched Project Row in Houston's Third Ward. It's impressive. The project took on 39 homes in the city's oldest Black neighborhood and transformed them. Dozens of shot gun houses that were left for blight ... literally became light. The project sheds light on enriching activities, art programs,

Does she have similar plans for her new city? "In Jackson, I am still exploring. My first priority is finding ways to have deeper engagement with the residents of Jackson, but also really put forth exhibitions that reflect Black and Brown people. That speaks to the kind of climate that we live in and creates strategies that are uplifting and not based in sorrow and pain. And, I also want to listen to the city and connect, and bring things that people want to see."

Ryan reminded me that African American artist Leonardo Drew's "A City in the Grass" is on display in the Art Gardens and can be enjoyed by the public for free with standard social distance guidelines.

I enjoy visiting the Mississippi Museum of Art – the state's largest art museum - and look forward to seeing how Ryan Dennis brings her special touch. "I want to know how I can support the various communities in Jackson. I would just love to have people visit the museum and have people connect with the museum. It's definitely here for everyone."

It forecasts changes in the region and seeks to identify transportation improvements needed to keep people and goods moving smoothly, while identifying a financially feasible list of proposed improvements. The plan is multi-modal addressing needs in roadway, public transportation, bicycle and pedestrian, rail and freight.
