Camera Rental Agreement

- **1. Rental Equipment:** The "Rental Equipment" refers to the camera(s), lens(es), accessories, and any other items rented by the "Customer" from the "Owner" (hereafter referred to as "Rental Provider").
- **2. Rental Period:** The rental period begins at the time the Rental Equipment is picked up by the Customer and ends when it is returned to the Rental Provider. The Customer agrees to return the Rental Equipment by the specified return date and time. Late returns may incur additional fees as outlined below.
- **3. Usage Restrictions:** The Customer agrees to use the Rental Equipment only for personal use and in accordance with any instructions provided by the Rental Provider. Commercial use of the equipment requires prior approval from the Rental Provider.
- **4. Security Deposit:** The Customer acknowledges that a security deposit may be required at the discretion of the Rental Provider. If a security deposit is required, the amount may range between 10% to 30% of the retail value of the Rental Equipment. The Rental Provider reserves the right to waive the security deposit requirement in certain circumstances. Any security deposit will be refunded to the Customer upon return of the Rental Equipment in satisfactory condition, minus any applicable fees for damage or loss.
- **5. Privacy Policy:** The Rental Provider respects the privacy of its customers and will handle personal information in accordance with its privacy policy. By renting the Rental Equipment, the Customer consents to the collection, storage, and use of their personal information for rental related purposes.
- **6. Late Return Policy:** In the event of a late return, the Customer agrees to pay a flat late fee of _____ per day for each day the Rental Equipment is returned past the specified return date and time. The maximum late fee shall not exceed ____.
- **7. Care and Use:** The Customer agrees to use the Rental Equipment responsibly and in accordance with any instructions provided by the Rental Provider. - **10. Reservation and Cancellation:** Reservations are subject to availability and must be made in advance. Cancellations must be made within a specified timeframe to receive a full or partial refund of the rental fee.

The Customer further acknowledges that providing false or fraudulent information may result in legal action being taken against them.
- **14. Agreement Acceptance:** By renting the Rental Equipment, the Customer acknowledges that they have read and agree to abide by the terms and conditions outlined in this agreement.
