

**MINUTES OF THE REGULAR SESSION OF  
ORANGE COUNTY EMERGENCY SERVICES DISTRICT #2  
FEBRUARY 18, 2026**

1. CALL TO ORDER – The regularly scheduled meeting of the Orange County Emergency Services District #2 was called to order at 6:00 p.m.
2. ESTABLISHMENT OF QUORUM – Quorum present, Commissioners LeBlanc, Childers, Barnes and Arnold.
3. PUBLIC COMMENTS – The following guests were in attendance: Chief Bodin; Asst. Chief Taylor; various firefighters; Brennan Dobbs; and Becky M. Buffington, District Administrator.
4. APPROVAL OF MINUTES FROM PREVIOUS MEETING(S) – The minutes from the January 13, 2026, regular session were presented. Motion made by Commissioner Arnold, seconded by Commissioner Barnes, to accept the minutes.

All voted AYE. Motion carried.

5. PRESENTATION AND APPROVAL OF DISTRICT ADMINISTRATOR'S FINANCIAL REPORT – The financial report for January 2026 was presented. A copy was provided to each Commissioner (copy attached). After review, motion made by Commissioner Childers, seconded by Commissioner Barnes, to accept the report and approve payment of all bills and expenditures as set out therein.

All voted AYE. Motion carried.

6. NEW BUSINESS

A. Discussion and possible action regarding purchase of one brush truck from Delta Industries – Chief Bodin reminded the Board that the District had previously been awarded a Forest Service grant for \$165,000.00 + match. He had contacted 3 different manufacturers for quotes and received the first round. After hashing out the specs, only 2 of the 3 returned quotes - Delta \$239975 and Siddons Martin \$273756. The difference being Delta has no loose equipment but the loose equipment cost is not worth the difference on the quotes. Also, Delta has a chassis ready to go and a 240 day build quote. We pay up front then the Forest Service reimburses \$165,000.00. After discussion, motion made by Commissioner Barnes, seconded by Commissioner Childers, to approve the purchase of one brush truck from Delta Industries, paying cash from funds in reserve accounts, and authorizing Chief Bodin and/or Ms. Buffington to sign all documents necessary.

All voted AYE. Motion carried.

7. COMMUNICATIONS FROM CHIEF, DISTRICT ADMINISTRATOR, ETC. – Chief reported meeting with K-Dan's owner. They will be building a new building on the vacant lot next to Station 2 (between their existing building and station). They have concerns with smoke from FTC, etc. Need to investigate mitigation issues. He was also contacted by someone wanting to buy the property next to Crumpler's - asking us to have property donated to us then sell it to them. Board said absolutely not. Discussion regarding numerous double tones last month and need to possibly expand duty crew hours to 24/7 and need to hire Captains as FT crew. President LeBlanc discussed pension board meeting last week.

Mr. Dobbs discussed status of repairs at the various facilities with the Board. Board has concerns regarding lack of coordination and completion - asked to put matter on agenda next month.

8. ADJOURNMENT – There being no further business, the meeting was adjourned at 6:48 p.m.
