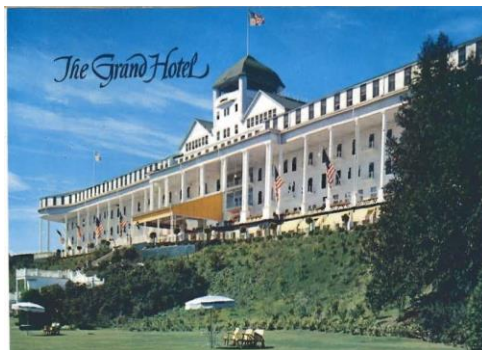

Payment: \$100 per person deposit due at booking and balance due 65 days prior to departure (check or money order only). Checks/money orders made out to Travel with Nance and mailed to 18696 Inkster Road, Redford, MI 48240.

Cancellation: \$20 per person cancellation fee if cancelled 65 days or more prior to departure. 50% per person fee if cancelled from 64 to 35 days prior to departure. No refund if cancelled 34 days or less prior to departure, unless passenger finds their own replacement or takes out insurance.
