15% Budget Cuts

On the first day of school we received conflicting messages from the 2 men in charge of our school system. Our mayor announced 15% budget cuts across all agencies to pay for newly arrived migrants. He went as far as to say that migration will destroy NYC. I don't believe that. NYC has historically experienced far greater numbers of migrants and was never destroyed. In 1907, 1.25 million immigrants came through Ellis Island. 300,000 of them settled in NYC just in that year. For perspective, over the past year, NYC has welcomed 100,000. So we've been here before. Conversely, our Chancellor expressed confidence on the first day of school. Confidence that our schools will do what they always do - meet students where they are and wrap them in any and all available support. And newcomers are always a boon to our school budgets, especially as our school enrollment declined due to declining birthrates and the pandemic.
