2. Presidents' Report - Ayanna Behin and Camille Casaretti, CEC13 and CEC15 Presidents

- This is a calendar meeting for CEC13 and a business meeting for CEC15. The meeting will begin as a
 joint meeting for both CECs but after the presentations both CECs will break up into their own group to
 conduct their meeting.
- Jeff Lowell from the Brooklyn Borough President's Office is here to give a presentation on Reso A funding and Assemblymember Jo Anne will talk about her bill on Dyslexia.

3. Reso A Funding Updates - Jeff Lowell, Deputy Policy Director, Office of the Brooklyn Borough President Eric L. Adams

- Wants to make sure all D13 and D15 schools apply for capital funding.
- Resolution A (Reso A) projects are school-specific capital improvement or enhancement projects that are funded by individual grants from New York City Council Members or Borough Presidents.
- Many schools qualify for capital funding. The application to apply takes less than an hour to complete.
- Some projects take a couple of years to get funded.
- Make sure to apply for things that are capitally eligible. Examples projects that are capitally eligible are: Improving auditoriums and gymnasiums, upgrading libraries, building science labs, refurbishing playgrounds, providing mobile science carts and supplying technology equipment.
- Air conditioning units, library books and photocopiers are not capitally eligible.
- All projects must meet a minimum cost requirement of \$35,000.
- The application period starts in December. Talks with the School Construction Authority (SCA) should start before applications open. Applicants should get a capital estimate from SCA to make sure enough money is requested for the projects.
- After applications are submitted there is a waiting period. City budget must be approved before any decisions are made.
- Schools receive notifications that their projects will be funded during the summer.

- Once the money has been allocated SCA is responsible for scoping out the project and overseeing the design and construction.
- Brooklyn Borough President Eric L. Adams has given over half of the budget to schools.
- Reso A can't cover air conditioning units, but will it cover wiring for the units? Wiring could be a capital funding project, maybe central air but that's too expensive.
- How about curtains for an auditorium? Total auditorium update yes, but not curtains.
- If the school has a project in mind, they should reach out to SCA to ask if that project qualifies for Reso A funding.
- Would soundproofing a classroom qualify? If the minimum cost is \$35,000 it might be approved, but the school should check with SCA first. This is a permanent improvement to the building, it could probably be approved.
- Is there a limit on how much to ask? There is no limit, but there is a limit on the city budget.
- Schools can apply for more than one project.

- If there is project that was funded more than 5 years ago, but a school is still waiting for this particular project let the Borough President's office know and reach out to the district's council member.
- Applications will open in December but the deadline will be in February. Please visit <u>Brooklyn-usa.org</u> to find out when applications open. You can also sign up for the <u>Brooklyn Borough President's Application Notification</u>.
- CEC15 President Camille Casaretti If submitting a project with the Borough President please inform your CEC so they can advocate for your project. CECs also submit a list of projects to SCA and knowing what schools are submitting it's very helpful.

4. Discussion about Dyslexia - Assemblymember Jo Anne Simon

- Assemblymember Jo Anne Simon wants to make sure she and her office help facilitate to get the information out in schools.
- If we call things by the correct name then we can get a handle of what we're dealing with. Teachers need to use the correct terms for disabilities to better teach their students with disabilities. Her bill is to make sure Dyslexia is call by the right word and that the correct word is used in IEPs.
- Lt. Governor of California Gavin Newsom is dyslexic. He shared his experience growing up with dyslexia during an interview.
- Dyslexia is a specific, language-based learning disability which is characterized by difficulties with accurate and/or fluent word recognition, spelling and decoding, verbal memory and processing speed.
 Secondary consequences may include: problems in reading comprehension, reduced reading experience, negative self-concept and decreased motivation.
- Dyslexia is not caused by a lack of motivation. It is not a visual problem. It is not a problem of laziness
 and it is not caused by parents not reading to their child. Dyslexia is not outgrown. Dyslexia is not a
 rare condition and it is not a lack of intelligence.

- Prevalence of including more children in general education classes, every teacher student or 5 in their class. Many will go unidentified until it's too late and they will continue to struggle with reading. It reduces the number of children who will need intensive individualized instruction.
- Goals promoted by the Dyslexia Guidance Memorandum Law:
 - o Accurate diagnosis of Dyslexia More specific than learning disability classification
 - Targeted treatment
 - Early intervention
- The bill makes sure the State issues a <u>guidance</u> on dyslexia to provide information to schools. Specific
 provisions of the Law are to use the words Dyslexia, Dysgraphia, Dyscalculia in NYSED to consult with
 stakeholders/interested parties.
- What evidence based education should look like:
 - A school climate where everyone in school is on board
 - The word dyslexia is consistently used
 - Small classes
 - Evidence-based methods
 - Knowledgeable, flexible, caring teachers
 - Consistency in instruction across all classes
 - A community to join where students know they are not alone

- Assemblymember Jo Anne Simon introduced Noah Rosenfeld, an 11th grade student.
 - Noah was diagnosed with Dyslexia when he was in the 3rd grade. He was terrified to read out loud when he was in 1st and 2nd grade. He thought there was something wrong with him. He is happy that he was diagnosed early because he was able to get early intervention.
 - Noah urged parents to have an open mind. There is nothing wrong with their child. Yes, it will take extra work but parents should work with their children.
- The <u>Wilson Reading System</u> breaks down language and helps students with the 5 pillars of reading: Phonemic awareness, phonics, fluency, vocabulary and reading comprehension.
- The goal is to have parents and teachers recognize what is Dyslexia. Teachers need to know why
 students are making mistakes.
