2. Charter Collaborations with the D15 Diversity Plan

- The D15 Diversity Plan is setting aside 52% priority for free or reduced lunch, ELL and temporary housing students. Middle schools in D15 are committed to diversity.
- Brooklyn Prospect Charter School's mission is to keep a 50-50 policy of students who are economically disadvantaged and non disadvantaged.
- Brooklyn Prospect Charter School began a preference process on 2011 when the number of students who qualify for free or reduced lunch started to decrease. About 45% of students currently attending the school qualify for free or reduced lunch.
- Representatives from Brooklyn Prospect Charter School want to make it known that the school is a leader in the D15 Diversity Plan instead of being pulled along.
