- Teacher Appreciation Week
- **School Liaison List** Our District 15 schools need our support more than ever, and now that our CEC is a bit smaller, the quantity of schools that we each represent must increase.
- Council Members and Covid-related Issues in our School Communities SLT Meetings have begun virtually

5. Discussion on Filling CEC15 Vacant Seats and Amending By-Laws

Due to three recent vacancies, (2 member seats and 1 ELL seat) we are now at 8 people on the council, a flyer to announce the open CEC15 3 seats, as well as a student member seat, has been drafted. To ensure an equitable representation of neighborhoods and communities, a brainstorm was done to discuss additional ways to provide outreach regarding these openings including asking the

PAR group members for ideas on outreach and asking PTA's to include the flyer in their email newsletters. The possibility of a CEC15 hosted info session event was also suggested.

6. Discussion on Student Advisory Group or Student Town Hall

Krystal, Casson, parliamentarian spoke to the importance of folding in student voices. During remote learning/Covid times we have an important obligation to work even harder to make sure we hear from students. The discuss resulted in the following take home points:

- A. Outreach to PC and principals with a specific set of questions about how/if their student governments are running and to possibly nominate students to a panel
- B. Outreach to Class Size Matters
- C. Outreach to Teens Take Charge
- D. Outreach to Superintendent to get the names of the students who are already involved in school leadership
- E. CEC15 could include student testimony on an agenda.
- F. Possible student-only town hall on the issue was raised
- G. CEC15 should draft letter to the Principals outlining Krystal Casson's vision for more student voices being folded in

7. Discussion on State Budget - Tia Schellstede, Borough President Appointee

The proposed drastic state budget cuts to education were discussed with BPA member Tia Schellstede. She read a draft of a letter opposing these cuts.

A roll call vote on the letter was made by Antonia Ferraro, VP2 and was seconded by Treasurer Kimmerly Scott and was approved unanimously.

The need for a rapid response team and rules around CEC logo use and sign-off on documents was discussed. It was decided the council needs a workflow document and approval process document. **A motion for a roll call vote on this**.

8. Discussion on Summer School and Back to School Planning

Gov. Cuomo gave a speech on May 4, 2020 outlining the path to reopening. He put schools in category 4 with event spaces and theaters.

CEC began a discussion as to what support the CEC can provide if schools start up for summer school? CEC began a discussion on childcare, schools reopening and the unequal burden on women. The idea of surveys for parents and children was discussed.

9. New Business - nothing to report
