### President's Report - Camille Casaretti, CEC15 President

As you know, the PEP is the governing body of the Department of Education. Although the majority of appointees are chosen by the Mayor, this new seat was written into the law because Parents were advocating for it. Our other Special Guest this evening is Joseph Lazarus, Director of School Facilities for the New York City Department of Education. We will hear about the school readiness plans for keeping our buildings clean and keeping students, teachers and staff safe once they return to the buildings.

**Next Monday, August 11**: I've scheduled a Curriculum Workshop Joint Meeting with CEC14 from 1pm - 2pm on The New 3Rs which is an anti bias, social justice based curriculum. Our CEC15 August Calendar Meeting is scheduled for **Tues, August 25** at 6:30 p.m and we are hoping to host Deputy Chancellor Karin Goldmark along with Executive Superintendent Karen Watts who will be in attendance to talk about Brooklyn North and details on back to school planning. Additionally, we have been invited to co-host a Brooklyn North Parent Feedback Session. I'll share more information about that as it develops.

A month from now, on Tues, September 8 at 6:30 p.m we have another CEC15 Business Meeting. The Office of District Planning and the PAR Team are hoping to report on the Preliminary PAR findings related to the Rezoning of SubDistrict 3. The PAR Team is also planning to hold virtual meetings on the next 4 mondays in August. The link will be sent out via email as soon as we receive it.

Additionally, keep in mind that the School Construction Authority will be scheduling a Joint Public Hearing Meeting with CEC15 and the Community Board to discuss a new property that was purchased recently by the DOE for a school. There will be a brief presentation and then CEC Members and the Public will be able to ask questions. We don't have a date yet for this meeting.

For those who are interested, CEC15 is still seeking a English Language Learner Representative and a Student Member for the Council. The ELL Member must have a student that qualifies for ELL status, or has received ELL services within the last 2 years. The student member must be an entering Senior that lives in District 15. A brief update on the Chancellor's Parent Advisory Council meeting this morning with Chancellor Carranza that happened this morning and was posted live on Facebook, to discuss school reopening.

The Chancellor and his cabinet are trying to answer as many questions as possible so that families can decide about signing up for blended in person learning or fully remote learning prior to the August 7th survey deadline.

If you have not received the link to the survey, please reach out to your school Principal or Parent coordinator as soon as possible. All schools should have contacted parents by now to ask about their preference for the start of the school year.

The Chancellor said that the "virtues and benefits of in person learning are profound. We know that nothing can replace the instruction that happens in the classroom. There are varying levels of comfort around in person learning during the pandemic." These are difficult choices and there is a lot of information but we need to be informed.

The DOE is preparing for a sense of readiness to move to fully remote learning if necessary. They are looking at the state guidelines. We shared the 145 page document at our last meeting. I will drop it in the chat again for your review.
