There were a lot of changes to the Education Law recently. We spoke about a few of them at our last meeting. One that hadn't been mentioned was a loophole that we brought to Senator Liu regarding a change to the definition of an existing school building. Because of this loophole, charter schools can take space in a new school with no regard for public hearings. In an effort to promote transparency and community engagement we are demanding that this loophole be closed. With so many new buildings coming on line in D15, we can not have our plans changed in the months prior to a new school opening. We hope you will support this change in the law.

As many of you know there was a rally at Tweed yesterday to restore the budget cuts. The mayor has until August 1st to restore funds and right now, he doesn't seem to want to budge. We need your voice and your advocacy to help fund our schools NOW. Forcing Principals to make critical spending decisions in the final hour, without access to their School Leadership Team is an outrage. This is literally the opposite of what any school community would want and it's all because of Mayoral Control.

We drafted a Letter to Mayor Adams which we will share now again at our Business Meeting, where I would like to call a vote.

Mayoral control creates incentives to make voters think that the mayor is fixing everything, even when the mayor doesn't have the power to fix everything. A just Fair Student Funding formula would likely show that the system needs more money, and mayors aren't likely to let that happen.

So until we #End Mayoral Control, we need to continue to speak out and have our voices heard.
