March 14, 2023 Business Meeting

President's Report - Camille Casaretti

District Updates:

Antonia and I went to **Albany** yesterday. We met with Senators Liu, Mayer, Chu, Parker, and Gounardes. We also met with Assembly Member Benedetto's staff. We discussed public school advocacy: Maintaining the Charter Cap, Giving NYC Transition Aid, Ending Charter School CoLocations, Creating more transparency and accountability in charter school reporting, Ending Rental Reimbursements, amending the open meetings law, and other legislative issues we support like:

- Universal Childcare
- Expanded After School Programming
- Funding for asylum seekers

- Fund the School Governance Study to be conducted by the Commissioner
- Fund Universal meals

Antonia adds - Sen. Liu and Mayer informed us that the Senate has no intention of lifting the regional charter cap or reissuing zombie charters. They will not add it to their one house bill. Additionally, Sen. Mayer indicated that they intended to include funding for the school governance study. That is the study that seeks to develop a more democratic form of school governance for NYC which is currently exclusively run by the Mayor. Also, in speaking to various legislators, there was interest in funding expanded afterschool programming, but no specifics.

Unfortunately, Transitional Aid is not something state legislators were willing to address without the direct advocacy of Mayor Adams. The Presidents of CEC16 and 17 and I had a meeting with Deputy Chancellor, Kenita Llyod and Mark Treyger to advocate for transitional aid. As we have discussed in prior meetings, NYC schools are eligible for hundreds of millions of dollars to compensate for enrollment loss to charter schools, but Mayor Adams must ask the Senate for it.

Back in Albany, we discussed the need for state funds for newly arrived asylum seekers and migrant students. The Mayor is focusing on obtaining Federal aid, but it seems the state could assist as well if asked. So if anyone is listening, please encourage the Mayor to ask the state for transitional aid and aid for asylum seekers. We have over 5,500 newly enrolled migrant students

in NYC. This number will continue to grow. The bottomline is NYC schools need all the support they can get from all available sources.

To follow up on something we were discussing at our last meeting regarding adding a possible **Restart Academy in District 15**.

Supt Alvarez has been in conversations with Superintendent Esperance about a new school space for students who are recovering from substance abuse. They are working together to find a location for the program to exist in our district. He reported that Supt Esperance is fully on board.

NY City Council Education Hearing tomorrow morning, March 15 at 9am to hear feedback on the Education Budget. We will be reviewing a Resolution on the Budget later tonight that asks for DOE to assure that the \$90 million in FSF funds provided to schools with a high concentration of homeless students and/or in poverty will not cause other schools to be cut by that same amount. In addition to this ask, we are also asking for clarity in reporting, that budget cuts from last year are restored and that the capital plan be expanded to meet class size mandates.

Update on Gowanus Neighborhood Rezoning: The City Council voted to adopt the Gowanus Neighborhood Plan on November 23, 2021. The Plan aims to support community goals such as **cleanup** of the Gowanus Canal and surrounding area, creating permanently **affordable housing** and diverse **job opportunities** and building and supporting schools, parks and other community resources and infrastructure. It was developed with community members and elected officials over the past four years. There will be a community meeting at PS32 on Wed, March 29 at 6pm. CM Hanif is hosting this public forum. Please plan to attend in person or via Zoom. Public advocacy has allowed for a \$250M capital improvement commitment.
