Vice President's Report - Antonia Ferraro Martinelli

Welcome everyone to this meeting at the Shirley Chisholm Family Residence in Sunset Park. This is a first for us. We normally meet in school buildings, but as our district has welcomed so many newcomers we wanted to go to those families and provide them with a forum to speak out about their challenges. We also have families in this district who are very dedicated to the work of mutual aid that supports new neighbors. I can tell you that many community members have expressed tremendous concerns to me about families forced to move to other shelters. They are actively advocating for policy solutions to prevent future forced transfers of families with school-aged children. Academically, socially, emotionally, and physically this is not a best practice. I would call it a worst practice. So I am excited to be speaking about this issue, in this brand new space that is a tremendous resource to our entire community, not just the residents. Thank you to Program Director Ania Bell for supporting our council's needs and making this meeting possible. We hope to have future meetings here to give families and students in temporary housing a voice.

Updates:

Budget Cuts

Mayor Adams announced a plan to slash 5% of the DOE's overall budget, which could take effect as early as mid-December. He has asked city agencies to submit plans for these cuts by Dec. 8. He has threatened to make a third round of cuts of equal size before June. Funding will be cut for after-school programs, early childhood education, computer science, community schools, mental health and more.

Here are some of the mayor's unacceptable cuts to school funding:

- \$120 million in cuts to 3K/pre-K program
- \$286 million in cuts to funded DOE positions
- \$96 million in cuts to after-school, substitutes and other per-session pay and Summer Rising
- Cuts to hours, days and ages for Summer Rising
- \$109 million from 653 schools due to enrollment
