Our schools are super charged with the entropy of orientations and re-orientations. Amidst all the fresh starts, I wanted to update you on recent changes to the D15 Community Education Council.

DOE's Foundation Aid formula proposed changes

In August, the DOE presented their recommendations for changes to the Foundation Aid Formula at a <u>CPAC meeting</u>. I wish the DOE had offered to provide the presentation to CECs.

As you may know, Foundation Aid is the largest single stream of state funding (\$9.9 B) that NYC Public Schools receive and for the first time in two decades the state is reviewing the formula. The Rockefeller Institute gathered feedback this summer in order to make non-binding recommendations on potential revisions to the Foundation Aid formula. It's likely that these recommendations will factor into the Governor's education budget proposal for the next fiscal year.

To summarize what the DOE requested

- 1. Update "Successful School District" Model on which the formula is based to better reflect current costs and educational expectations
- 2. Provide support for STH and Foster Children (NYC added a city weight for 2023-24)
- 3. Expand and differentiate funding based on need (as NYC already does) for Special Ed and MLL students
- 4. Review Regional Cost index (costs have risen downstate)
- 5. Provide aid to support implementation of new class size mandates (est. cost \$1.4M -\$1.9)

I met with Mia Perez, Shahana Hanif's Education and Land Use Director to discuss some priorities for the coming year, chief among them SCA accountability. We had a long discussion about ways that the City Council can hold SCA accountable.

The 3 person board of the organization is appointed by the Mayor which includes the Schools' Chancellor and two others. It was reported again last week that one of the three trustee seats remains unfilled after a year. The organization clearly lacks oversight. We see it every day in the projects that drag on, are mismanaged, poorly executed, costing the taxpayer and preventing our children from full use of school buildings. And as our city works to comply with the Class Size Mandates we really need a competent, responsive SCA that partners with our schools. So I intend to reach out to more electeds on this front. I think this could be an excellent advocacy priority for our council at large and or our legislative committee.

NEW Student OMNY Cards.

NYC Public School students can use their OMNY Cards on subways and buses for <u>four free</u> <u>rides a day</u>, all year long, including weekends and summers.

When your child taps their new Student OMNY Card, they can:

- Ride MTA subways and buses for free, up to four times a day
- Use their Student OMNY Card all day (not just during certain hours)
- Tap to ride every day of the year, even on weekends and holidays (not just school days)
- Use the same card for the entire year, including over the summer

And many of our children are excited about their new Student OMNY Cards. My daughter told me she is going to go everywhere! But as excited as some students are, others are left out. I am hearing feedback from parents of students with disabilities who receive busing, that the distribution of OMNY cards is discriminatory, particularly for students who receive busing. These students do not receive the benefit of busing from afterschool programs or to and from Saturday programs or weekend school events and during the summer.

I inquired about this and the response was that:

For students receiving busing, but participating in afternoon or weekend activities, schools can request 2 trip OMNY cards via an online form. That is a separate OMNY card meant specifically for this purpose.

I received some great feedback from a parent that *They need to add this to the OMNY section on the NYCPS website. Parents shouldn't have to figure it out.* And that even with this remedy it is not quite equal. *Because a student is provided busing their access to a student-issued MetroCard should not be limited and families should not have to go through an online form to access a limited MetroCard. There have been recent reports of parents having to take their children to school in car service because of the failures from OPT and these families have yet to be reimbursed for the cost of transportation.*

This is something I am going to continue to keep an eye on and it could be a good resolution as well. Vanessa volunteered to work on it, but I am hopeful that the DOE will be responsive and a resolution won't be necessary.

Have D15 Schools lost After-school programs due to state funding shifts? No.

District 20 reached out to me because some of their schools lost afterschool programs.

The NY State Office of Children and Family Services had recently consolidated two funding programs into a streamlined initiative known as the <u>New York State Learning and Enrichment After-School Program Supports</u>, or "LEAPS" — forcing providers to reapply.

The District 15 office confirmed that none of D15's after schools were impacted by this.

First I want to re-update everyone on the CEC15 member vacancies. Lauren Barkan, our IEP rep, resigned effective July 2nd, and Mamun Rashid, our MLL rep resigned July 16, so, last month we announced two vacant seats and began accepting applications.

(Lauren Barkan was the IEP representative. According to FACE, the next CEC member, who is currently the parent of a child with an IEP, with the most votes becomes the IEP rep. That member is Nancy Randall. Nancy became the IEP rep and the seat became available to a general member. In the case of the MML seat, we do not have another parent who qualifies as an MLL representative parent, so in order to qualify a candidate must be the parent of a student who is a designated English Language Learner.)

We sent out an email blast to announce the vacancies with flyers in 6 languages. An evening of interviews took place Tues, Aug. 13 and at our August Business Meeting on Aug. 20. We announced a deadline of Sept 3 to accept final applications. We received 3 more applications and this will be the final interview. In total, we received 1 application for the MML seat and 10 applications for the general seat. Members of the public can read all the candidates' statements in the document that I will drop in the chat.
