 - a. Contracts for Excellence FY 2022 Antonia attended a hearing for the Contracts for Excellence for FY 2022 in the borough of Brooklyn last Thursday evening. The state will fully fund foundation aid over the next 3 years. The Contracts for Excellence is a set aside amount from the state foundation aid that is subject to categorical spending requirements. There will be district hearings on how the C4E money is going to be allocated. The total C4E amount for FY2022 is \$531 million, from which \$183 million is embedded in Fair Student Funding. The remaining \$348 million of C4E will be distributed through SAMs (School Allocation Memos). The presentation given at the hearing described how the SAMs portion is allocated. This document contains Table 1 Contracts for Excellence School Allocation. Here you can see the amounts allocated to schools by SAMs by district.
