Let the record show that New York City Council Member Alexa Aviles is in attendance. Addressing the concerns of parents and schools with immigration enforcement and the rollbacks that are taking place under the Trump Administration. There have been no verifications of engagement taking place in schools. It is important to encourage families, that sources of media should be verified before posting on social media because it causes a lot of panic and harm. Information that families and children need to know are; "you do not have to open the door, you do not have to talk, you do not have to consent for someone being outside of your door, a judicial warrant with a judges name on it needs to be visible, you can ask for a lawyer, do not present any documentation, you should not carry any foreign identification on you, it should be in a safe place. If you have NYC ID you can certainly present the ID. You do not have to answer an NYPD officer, under no circumstances should an NYPD officer be asking the status of your immigration status, you can refuse to answer that question.
