Universal Screeners

District 15 is planning a Family Workshop on Using Universal Screener Data to Inform Instruction, for April 9, 2024, from 10 - 11 am. I will share my screen so you can pick up the QR code from the flier. We will also share the flier on our website and in email.

Covid Relief Funds

Over the last few years, the NYC Department of Education has been using \$7 billion in temporary federal COVID-19 relief funds for important programs, such as 3-K, preschool special education, 450 school social workers, community schools, school nurses, restorative justice, 60 school psychologists, 75 coordinators working in

homeless shelters, bilingual staff, translation and interpretation, dyslexia and literacy initiatives, and more. The federal funds will run out in June 2024, and there is not yet a plan for what comes next. The State Budget is due April 1 and the City Budget is due in June. There is little time to act.

Loss of Covid Relief Funds will impact District 15 schools. I know our Superintendent will be working with principals to mitigate this as much as possible but the threat is real. Remember those shelter coordinators we fought for? They could be gone, along with many other vital programs.

We could lose:

- 16 social workers
- restorative justice at 9 schools
- 3 shelter-based coordinators
- 3 Learning to Work programs
- 3 community schools
- bilingual programs at 3 schools
- 2 - 3K integrated classrooms
- 1 pre-K special ed program

Please take a look at the one-pagers that illustrate the risks to programs in schools in District 15. City Council will hold hearings on March 18th. Speak out! Tell them what's at stake for your school.

Testify at the City Council Education Budget Hearing (3/18): The City Council education budget hearing is taking place on March 18th. You can testify (read a statement of up to two minutes) in person at City Hall or via Zoom. While the hearing starts at 10am with the NYC Department of Education's testimony, public testimony is scheduled to begin **after 2:30pm and will likely last into the evening**. It would be great to have parents, students, educators, advocates, and others talk about the impact of losing one or more of the education programs on the chopping block.
